This project is coordinated by the City Beautiful Commission, the Public Works Department and City's Horticulturist Michael Engler. Third grade students were given seedlings to plant at their residences.

The Volunteer Salute will be held April 18, 2002 to show appreciation to all volunteers serving the City of Centerville.

Congratulations were extended to Heartland of Centerville having been found in total compliance with all rules and regulations for nursing homes.

Mr. Horn reported the following during his City Manager's Report:

The City's new Public Works Director Rob James was introduced. Mr. James began his employment on Monday, April 1, 2002.

The new nine holes at The Golf Club at Yankee Trace is being prepared for a late June, 2002 opening. Restroom facilities are currently being constructed at hole number fifteen of the existing course and at hole number five of the new nine holes. Road work continues with the widening of Paragon Road where the old course and new course join.

Progress on the Alexandersville-Bellbrook Road improvement project has been slowed due to weather conditions.

The bid for the City's street resurfacing project for various streets in the City of Centerville will be accepted later during this meeting. Work is expected soon after award of the bid.

Ron and Leslie Newcomb are Chairing the BUY.COM Dayton Open Charity Auction. New committee members have displayed a lot of interest and enthusiasm for this event which will be held on Tuesday, July 9, 2002, during the golf tournament.

In the May issue of the Golf Digest The Golf Club at Yankee Trace was listed in the top ten (7th) golf courses in America.

Miss Lightle outlined code violations and resolutions for the month of March, 2002, as well as the community calendar for the coming month.

YANKEE TRACE SECTION 25A RECORD PLAN (REPLAT)

Mr. Shrimplin reviewed the Record Plan for Yankee Trace Section 25A, for property located at the northeast corner of Yankee Trace Drive and Kenworthy Place. The replat consisting of a .736 acre lot and a reserve area is zoned R-1c, Single-Family Residential. The purpose of this replat is to combine a portion of Reserve Area BO with existing Lot 211 which increases the overall size of the newly created lot. Mr. Shrimplin located the subject property on a map. The property owners are receptive to the addition of a portion of the Reserve Area to their lot. The Planning Commission, by unanimous vote, recommended approval of this Record Plan to City Council as submitted. Upon question of Mr. Singer, Mr. Shrimplin advised that the subject acreage was designated as part of the Reserve Area on the Record Plan, for Section 25; due to the configuration of the Street, it is more appropriate for the acreage to become a residential lot. Mr. Singer moved that the Record Plan for Yankee Trace, Section 25A be approved as recommended by the Planning Commission. Dr. Gresham seconded the motion. The motion passed unanimously.

Mr. Cline reported that the Long Range Comprehensive Plan Committee held a kick off meeting of the Steering Committee. Washington Township is considering joining the City of Centerville in this venture. The City's Consultant ACP made a presentation to the Washington Township Trustees, the Planning Board and the Board of Zoning Appeals. Cost figures will be revised by the Consultant to include Washington Township. Action by the Washington Township Trustees hopefully will be taken during the first part of May. Mr. Cline is very optimistic that Washington Township will join the City of Centerville for the development of a Comprehensive Plan for the entire area.

ORDINANCE NUMBER 6-02 0.161, 0.137 ANNEXATION

The Public Hearing was held concerning Ordinance Number 6-02. Mr. Horn explained this proposed Ordinance to annex two small parcels of land consisting of 0.161 acres and 0.137 acres owned by the City of Centerville in the area of Paragon Road. The purpose of this petition for annexation is to square off the City's right-of-way along the Paragon Road corridor. Mr. Kingseed sponsored Ordinance Number 6-02, An Ordinance Authorizing The Annexation Of Contiguous Territory Owned By The City Of Centerville And Directing The Municipal Attorney To Prosecute The Proceedings Necessary To Effect Said Annexation, and moved that it be passed. Mr. Krass seconded the motion. The motion passed with six ayes in favor of the motion, Mr. Singer abstained.

RESOLUTION NUMBER 15-02 ROADWAY REPAIRS AGREEMENT WITH MONTGOMERY COUNTY

Mr. Horn reviewed a proposed Agreement between the City of Centerville and Montgomery County which grants the City the authority to arrange for permanent repairs to City roadways made necessary by County repairs to water main breaks, sewer maintenance, and manhole and valve box grade adjustments. He explained how these repairs are made by the City's contractor improving the response time and the quality of the needed repairs. Dr. Gresham sponsored Resolution Number 15-02, A Resolution Authorizing The City Manager To Enter Into An Agreement Between The City Of Centerville And The Board Of County Commissioners Of Montgomery County For Permanent Repair Of Roadways Necessitated By Water And Sewer Repairs, and moved that it be passed. Mrs. Lienesch seconded the motion. The motion passed unanimously.

RESOLUTION NUMBER 16-02 AGREEMENT WITH ROBERT FARQUHAR

Mr. Horn reviewed a proposed Resolution in order to settle an issue involving the City of Centerville, the Public Employees Retirement System and the City's Law Director Robert Farquhar. The City has been working with PERS for the past several months relative to Mr. Farquhar's employment and service to the City of Centerville. Conflicting opinions have been received from PERS relative to whether or not Mr. Farquhar was an independent contractor or an employee of the City. RESOLUTION NUMBER 17-02 DAYTON OPEN FACILITIES AGREEMENT

Mr. Horn reviewed a proposed Resolution to authorize him to execute an Agreement on behalf of the City of Centerville with Dayton Open for the use of The Golf Club at Yankee Trace for the 2002 BUY.COM Dayton Open Golf Tournament. The dates of the tournament are July 8 through July 14, 2002; the rental of the facility will cost the Dayton Open \$65,000.00 for the entire term. Mr. Krass sponsored Resolution Number 17-02, A Resolution Authorizing The City Manager, On Behalf Of The City Of Centerville, To Execute A Contract With Dayton Open, and moved that it be passed. Mr. Cline seconded the motion. The motion passed unanimously.

RESOLUTION NUMBER 18-02 DAYTON OPEN MANAGEMENT AGREEMENT

Mr. Horn reviewed a proposed Agreement between the City of Centerville and Dayton Open to provide for the management of day to day tasks and other services necessary to assure the success of the 2002 BUY.COM Dayton Open Golf Tournament at The Golf Club at Yankee Trace. The City will provide for the operation of the tournament as well as food service. Dr. Gresham sponsored Resolution Number 18-02, A Resolution Authorizing The City Manager, On Behalf Of The City Of Centerville, To Execute A Contract With Dayton Open, and moved that it be passed. Mrs. Lienesch seconded the motion. The motion passed by unanimous vote.

RESOLUTION NUMBER 19-02 STREET RESURFACING PROGRAM

Mr. Horn advised that the City received quality competitive bids for the 2002 Road Improvement Project. Mr. James reviewed the following three bids received for asphalt overlay and concrete repairs to various streets in the City of Centerville:

The lowest bid was received from the Shelly Company formerly known as the L. P Cavett Company. City Staff recommended acceptance of the bid received from the Shelly Company in the bid amount plus \$62,017.60 for contingencies and overruns for a total of \$800,000.00. The completion date has been set for August 23, 2002. Mrs. Lienesch sponsored Resolution Number 19-02, A Resolution Accepting The Bid Submitted By The Shelly Company For The 2002 Concrete Repair And Asphalt Resurfacing Road Improvement Project In The City Of Centerville And To Authorize The City Manager To Enter Into A Contract In Connection Therewith, and moved that it be passed.
