Mr. Horn outlined the current status of the BUY.COM Dayton Open Golf Tournament relative to financial issues and organizational slots to be filled. The PGA will supply a Tournament Director at their expense who will remain locally throughout the end of the tournament if it is held at The Golf Club at Yankee Trace.

Mr. Leone expressed two concerns of the Board: the quality of the tournament and contributions to charities. The Board stands firm with giving \$125,000.00 to charities, however they will agree to revise their goal to consider the contribution of \$110,000.00.

Mr. Bayley offered his assurance that the Southern Ohio PGA will solicit and coordinate volunteers and the PGA can supply the right type of operations director.

Mr. Horn expressed his concern that the tournament, if held at The Golf Club at Yankee Trace, must end on a strong foot, with a decent balance, and an expansion be made to the Board.

Mr. Caufee reassured Council that they want to move forward with the BUY.COM Dayton Open.

As a result of further discussion without the PGA Staff in attendance, it was agreed that the Contract should include the following:

A Tournament Director's salary and expenses will be paid by the PGA.

The PGA give the tournament one day free at TPC River Bend, the date to be determined.

The contract take effect only after written consent has been received from the Southern Ohio PGA that they will coordinate the volunteers and supply all staff needed during the tournament.

The scoreboard fee of \$5,000.00 be waived.

The \$5,000.00 contribution to First Tee be waived.

The \$1,000.00 fee for the website be waived.

The PGA will provide Charity Auction items.

The roughs will not be maintained the same length as they were in the year 2000.

In consideration of these concessions by the PGA, City Council concurred to move forward with the BUY.COM Golf Tournament at The Golf Club at Yankee Trace.
