The summer concert series will begin in the Leonard E. Stubbs Memorial Park on Sunday, July 4, 1999, preceded by a reception at Yankee Trace for the Americana Festival Grand Marshals. Concerts will be held in the park on Thursdays and Sundays according to the schedule published in the Town Crier.

ORDINANCE NUMBER 7-99 LANDMARK DESIGNATION PETER SUNDERLAND HOUSE

The Public Hearing was held concerning Ordinance Number 7-99. Mr. Feverston reviewed this City Initiated Application for Landmark Designation for the Peter Sunderland House located at 595 East Alexandersville-Bellbrook Road on a 13.34 acre parcel of land owned by Michael LeMaster. The zoning of the subject property is B-PD, Business Planned Development. The application is for the preservation of the original significant portion of this old limestone house plus the rear addition containing a pitched roof. The two-story garage, connector, and the flat-roof additions are excluded and may be removed. Mr. Feverston located the subject property on a map and outlined adjacent land uses. This historic house was included on the Master Plan previously approved by City Council for the construction of the RETS Technical Center which is located to the immediate south of the Peter Sunderland house. The Board of Architectural Review, by unanimous vote, recommended the passage of an Ordinance to designate the Peter Sunderland House as a Landmark.

Adrian Rose, 104 Cushwa Drive, offered his support for the Landmark Designation and restoration of the Peter Sunderland house.

Mr. Reppert sponsored Ordinance Number 7-99, An Ordinance To Designate The House Addressed As 595 East Alexandersville-Bellbrook Road And Known By Local Historians As The Peter Sunderland House, As A Landmark Within The City Of Centerville, Ohio, And Amending Ordinance No. 8-91, An Ordinance Establishing Certain Houses, Buildings, Structures, Areas, Or places As Landmarks Within The City Of Centerville, Ohio, And To Establish Procedures And Requirements To Regulate The Renovation, Rehabilitation, Remodeling, Addition, Alternation, Development, Construction, Or Demolition Of A Designated Landmark, and moved that it be passed. Mr. Kingseed seconded the motion. The motion passed unanimously.

2000 TAX BUDGET

The Public Hearing was held concerning Centerville's Tax Budget for the year 2000 for submission to the Montgomery County Auditor for consideration by the Montgomery County Budget Commission. Mr. Bettcher explained the fact that this is the estimated County tax Budget for the City of Centerville, which by law, must be submitted on or before July 21st. Failure to comply with this will result in the loss of the City's local government fund. The City's estimated receipts for the year 2000 is \$20,552,520.00. Mr. Stone moved that the Tax Budget for the City of Centerville for the year 2000 be approved for submission to the Montgomery County Auditor. Mr. Cline seconded the motion. The motion passed by unanimous vote.

Dr. Michael DeBord, 1620 Silverlake Drive, appeared before Council at this time relative to the Planning Commission's approval of a Preliminary Plan for Section 21 in Yankee Trace. Mr. Feverston explained this application submitted by the Yankee Trace Development Company for a residential cluster development as part of the community lifestyle approved for Yankee Trace several months previous. This Plan which details lot layouts and roadway configuration was submitted to the Planning Commission for final approval. Following will be the submittal of a Record Plan to the Planning Commission for a recommendation to City Council. Dr. DeBord expressed concern with the narrow setbacks between homes, the development of vacant land which neighbors believed would be parkland, the view of the lake being obstructed by two story buildings, and the lack of commonality between this development and the established homes to the north. Mr. Feverston described Section 21 as a single-family residential development, with ten feet between homes, neo-traditional design with picket fences along the street, gas lights as used throughout Yankee Trace, and sidewalk on both sides of the street. Mr. Feverston explained the fact that the lake, which did not previously exist, was created as part of the irrigation system for The Golf Club at Yankee Trace, The density approved for the lifestyle community is 3.70 dwelling units per acre. The applicant in this case is proposing a density of 3.05 units per acre.

Adrian Rose, 104 Cushwa Drive, expressed appreciation to the City of Centerville for flower and tree beds being put in place on North Main Street.

Laverne Pearson, 1516 Silverlake Drive, expressed concern with potential flooding in his neighborhood with the development of Section 21 in Yankee Trace and questioned whether adequate land was available north of the lake for the construction of the homes as proposed. Mr. Horn explained the fact that the land north of the lake is developable; lots in this area have been included on plans for several years. The developer must build within FEMA boundaries; elevations will be required to meet FEMA standards. Homes will be located on only one side of the street.

Bill Kemp, 1615 Silverlake Drive, expressed concern with the proposed alleys to be constructed along the rear of the homes in Section 21. Mr. Feverston advised that it will not be a typical alley; it will be a private lane or drive to access the homes in that particular area. He explained how there will be a separation between the private drive and the homes to the north which will vary in width. Landscaping, screening, mounding, or fencing will be addressed in this area when the Record Plan is considered to provide separation between the two different housing types.

Verlee Raasch, 1651 Heritage Lake Drive, cited the lack of maintenance by Yankee Trace for that area located adjacent to her property and other areas west of Yankee Street. Mr. Horn pointed out that the area just west of 1651 Heritage Lake Drive is the next section of Yankee Trace to be developed.

RESOLUTION NUMBER 20-99 SALE OF BULLETPROOF VESTS

Mr. Horn advised that the Police Department has bulletproof vests which have exceeded the service life for the daily use by a police officer. Chief Walker has recommended that some of these vests be used for training purposes by Sinclair Community College's Basic Police Academy. Mrs. Lienesch sponsored Resolution Number 20-99, A Resolution Authorizing The Disposal Of Ten Used Bullet Proof Vests By The Sale Of Same For The Sum Of \$1.00 To Sinclair Community College, A Public Body, In Accordance With The Provisions Of Section 212.05 Of The Centerville Municipal Code, and moved that it be passed. Mr. Reppert seconded the motion. The motion passed unanimously.

RESOLUTION NUMBER 21-99 SET DATE TO DESIGNATE PUBLIC DEPOSITORIES

Mr. Bettcher reported that every two years agreements must be renewed for the deposit of public funds of the City of Centerville in area banks. The City currently has contracts with eight banks for the deposit of said funds, contracts which will expire on August 22, 1999. It is necessary for City Council, by Resolution, to estimate the amount of public monies to be deposited for a period of two years. Awards will be made during the Council Meeting scheduled for July 19, 1999. Mr. Reppert sponsored Resolution Number 21-99, A Resolution Estimating The Probable Amount Of Public Monies To Be Deposited, Setting A Date For The Designation Of Public Depositories And Authorizing Notice, and moved that it be passed. RESOLUTION NUMBER 22-99 CABLE TV FRANCHISE TRANSFER

Mr. Horn outlined discussions which have transpired between the Miami Valley Cable Council and member Municipalities relative to the transfer of the Cable TV franchise from Media One to Time Warner Entertainment Company. Details have been worked out, concerns have been satisfied, and the Cable Council recommends to all member Municipalities approval of this franchise transfer. Mr. Stone sponsored Resolution Number 22-99, A Resolution Acting On The Request Of Media One To Transfer Its Cable Television Franchise To Time Warner Entertainment Co., L.P., and moved that it be passed. Mr. Kingseed seconded the motion. The motion passed by unanimous vote.

RESOLUTION NUMBER 23-99 CITY HALL PARKING LOT IMPROVEMENTS

Mr. Weaver reviewed bids received for improvements to the City Hall Parking Lot which includes curbing, gutter installation, drainage improvements, asphalt overlay, and entrance improvements to the property. The following bids were received:
