Briefly discussed was the Record Plan for Bethany Commons at Yankee Trace. Mr. Horn advised that Bethany has agreed to place in escrow \$130,000 which is their anticipated share of the construction cost to widen Yankee Street. Montgomery County is developing plans to widen Yankee Street and will coordinate the design plans with Bethany. Mr. Horn recommended that the Record Plan for Bethany Commons be approved with the understanding that the City of Centerville will not be expected to defray any of the construction cost for this roadway improvement.

Discussion followed relative to the fact that just one bid was received for the Yankee Street Road Improvement Project. Although the bid received was higher than the Engineers estimate, Mr. Horn recommended that it be accepted so that construction may begin in a timely manner.

Mr. Horn advised that the Centerville City School Board has agreed to pay 1/3 of the cost for a feasibility study relative to a Performing Arts Center for the community.

Mr. Kingseed, speaking as Chairman of the Architectural Preservation District Task Force, advised that letters have been sent to affected property owners relative to possible improvements in the northwest quadrant of downtown Centerville.
