ORDINANCE NUMBER 19-98 ZONING ORDINANCE AMENDMENT TEXT

The Public Hearing was held concerning Ordinance Number 19-98. Mr. Feverston reviewed this proposed Ordinance to regulate the construction of large scale developments within the City such as employment centers, business centers, and retail establishments; to provide for sidewalks within the development; to break up vehicular parking throughout the development; and to control the architectural design, scale, shape and mass of these facilities. He cited structures already constructed in the City of Centerville in accordance with guidelines provided by the proposed Ordinance. The Planning Commission, by a vote of 6-0, recommended approval of this Zoning Ordinance text amendment to City Council. Mr. Reppert sponsored Ordinance Number 19-98, An Ordinance Amending Ordinance Number 11-86, The Zoning Ordinance Of The City Of Centerville, Ohio, To Establish Architectural Design, Massing, And Building Material Regulations And Procedures For All Non-Residential Uses, and moved that it be passed. Mr. Singer seconded the motion. The motion passed by unanimous vote of City Council.

RESOLUTION NUMBER 20-98 SAFE PLACE PROGRAM

Mr. Horn reviewed a program proposed for the Centerville/Washington Township community known as the Safe Place program to create a network of businesses and public locations designated as safe places for any young person in trouble to enter and request help. This program has been implemented by Daybreak located in the City of Dayton. Mr. Horn advised that the Washington Township Fire Department has supported this program with locations in all fire stations. The Centerville Police Department has utilized Daybreak on approximately ten to twelve occasions during the past year. The Safe Place program will provide troubled youths a site
