Mr. Horn explained that Montgomery County disqualified the bid received from Allied Builders, Inc., because Allied failed to attend a mandatory Pre-bid meeting held in the Council Chambers on September 17, 1996. The Project will include 31 curbs and the low bid is recommended. Mr. Reppert sponsored Resolution Number 52-96, A Resolution Accepting The Bid Submitted By TdM Construction Company, Inc., For The Village South Handicap Access Ramp Project - 1996 (CDBG Project) For The City Of Centerville And Authorizing The City Manager To Enter Into An Agreement In Connection Therewith. Mr. Compton seconded the motion. The motion passed by unanimous vote of City Council.

YANKEE TRACE SECTION FOUR, SECTION SIX BOND REDUCTION

Mr. Horn reviewed a recommendation of City Engineer, Norbert Hoffman, that Yankee Trace Sections Four and Six are being combined into a single section, Section 6A, and duly recorded as a subdivision with public right-of-way and individual lots. The individually posted Letters of Credit for Section Four and Six are being adjusted and combined within this recommendation per the request of the developer. The Yankee Trace, Section Four Letter of Credit has already been reduced to \$21,000.00 for public improvements and the \$9,000.00 Letter of Credit for the Hiker/Biker Trail remains in place. With the completion of work to date, it is recommended that the Letter of Credit for Section Six be reduced from \$73,270.00 to \$11,000.00. This reduced amount is sufficient to cover repair work and the remaining plat improvements and final lift of asphalt. Mr. Singer moved that the Letter of Credit posted on Yankee Trace Section Six be reduced from \$73,270.00 to \$11,000.00 as recommended by the City Engineer. Mr. Compton seconded the motion. The motion passed unanimously.

This reduced Letter of Credit for Yankee Trace Section Six may be combined with the \$21,000.00 Letter of Credit that currently exists for Section Four to create a single Letter of Credit in the amount of \$32,000.00 for the renamed Yankee Trace 6A. The separate Letter of

Credit for \$9,000.00 will remain for the Hiker/Biker Trail.

There being no further business, the meeting was adjourned.
