The Council of the City of Centerville, County of Montgomery, State of Ohio, met on Monday, February 13, 1995 at 8:00 P.M. in the Council Chambers of the Centerville Municipal Building. The Meeting was opened with an Invocation given by Councilmember James Singer and the Pledge of Allegiance to the Flag with Mayor Shirley Heintz presiding. Mr. Compton moved that Councilmember Mark Beasley be excused from this meeting. Mr. Kingseed seconded the motion. The motion passed by unanimous vote.

RESOLUTION NUMBER 12-95 GOLF FINAL PAYMENT FOR COURSE

Mr. Horn reviewed a proposed Resolution to ratify negotiations between the City and Ohio Farmers Insurance Company for the completion of all construction activities at The Golf Club at Yankee Trace involving the bonding company. He outlined events which took place beginning with the bid award to Irvin Construction and the ultimate involvement of Ohio Farmers Insurance Company for the completion of the construction of the golf course. Due to financial difficulties, Irvin Construction was removed from the project and the Performance Bond was claimed, thus Ohio Farmers Insurance Company became the General Contractor. They, in turn, hired Midwest Construction to complete the project. The City and the Insurance Company have now come to agreement on quantities and field verifications resulting in a final payment of \$42,911.00 to Ohio Farmers Insurance Company. Upon suggestion of Mr. Singer, Mr. Horn pointed out the fact that with this closeout with the bonding company, the City assumes the responsibility for the coordination for some construction items yet to be completed at Yankee Trace. The City has received a Maintenance Agreement from Ohio Farmers Insurance Company for a period of one year. Mr. Compton and Mrs. Beals complimented City Staff for excellent work to complete The Golf Club at Yankee Trace. Mrs. Beals sponsored Resolution Number 12-95, A Resolution Ratifying Negotiations Between The City Manager And Ohio Farmers Insurance Company For Final Adjustments And Payment For The Completion Of All Construction Activities Associated With The Golf Club At Yankee Trace, and moved that it be passed. Mr. Kingseed seconded the motion. The motion passed unanimously.

RESOLUTION NUMBER 13-95 EDGE MEMBERSHIP UNION

Mr. Horn reviewed correspondence received from the Board of County Commissioners of Montgomery County relative to offering membership to all four non-participating jurisdictions in the Economic Development/Government Equity Program for the remainder of the participation agreement term. The City of Union and the Village of New Lebanon have requested membership in the EDGE Program effective 1995. Member entities have indicated concurrence with this proposal. Mr. Stone sponsored Resolution Number 13-95, A Resolution Approving The Participation Of The City of Union As A Member of The ED/GE Program, Effective 1995 Through The Year 2001, and moved that it be passed. Mr. Compton seconded the motion. The motion passed unanimously.

RESOLUTION NUMBER 14-95 EDGE MEMBERSHIP NEW LEBANON

Mr. Singer sponsored Resolution Number 14-95, A Resolution Approving The Participation Of The Village Of New Lebanon As A Member Of The ED/GE Program, Effective 1995 Through The Year 2001, and moved that it be passed. Mr. Stone seconded the motion. The motion passed by unanimous vote.

RESOLUTION NUMBER 15-95 YANKEE TRACE CLUBHOUSE FURNISHINGS

Mr. Horn explained the fact that Bid Specifications for a Yankee Trace Clubhouse Interior Furnishings Package were prepared by Architects Associated and Centerville Design Associates. Mr. Haverland reviewed the following bids received for furnishings for the Clubhouse at Yankee Trace, three being received from interior design firms and three from office equipment firms:

Mr. Haverland recommended that portions of bids be accepted as follows:

Oakwood Interiors, Inc. \$ 77,568.85 Seitz & George Office Equipment Company 48,293.45

for a total amount resulting in \$125,862.30, a difference of \$39,137.70 from the Architect's estimate of \$165,000.00. By dividing the package into two parts, the City experiences a cost savings of \$19,158.66. Upon question of Mayor Heintz, Mr. Haverland advised that the bidders will meet delivery dates as specified in the Bid Specifications. Mrs. Beals sponsored
