ORDINANCE NUMBER 19-95 GOLF PROFESSIONAL INSTRUCTION FEES

Mr. Horn outlined the need to establish a fee structure for payment to golf professionals at The Golf Club at Yankee Trace for lessons given in excess of their normal working hours. The Ordinance provides for a split of no more than 75% of the gross revenue being paid to the golf professional with the remaining revenue going to the City of Centerville. These provisions to be in effect retroactively beginning March 1, 1995 and remaining in effect until December 31, 1995. Mr. Farquhar explained the fact that this Ordinance is necessary due to a provision in the Centerville City Charter which requires that all fees received by officers or employees of the City in connection with their employment and the use of Municipal facilities be accounted for and paid into the City's treasury. Mr. Stone sponsored Ordinance Number 19-95, An Emergency Ordinance Establishing Compensation Rates For Lessons Given By Golf Professionals At The Golf Club At Yankee Trace, and moved that it be passed. Mrs. Beals seconded the motion. The motion passed unanimously.

ORDINANCE NUMBER 20-95 GOLF PROFESSIONAL INSTRUCTION FEES

Mr. Singer moved that Ordinance Number 20-95, An Ordinance Establishing Compensation Rates For Lessons Given By Golf Professionals At The Golf Club At Yankee Trace, be set for Public Hearing on September 18, 1995. Mr. Compton seconded the motion. The motion passed by unanimous vote.

Mayor Heintz read this proposed Resolution prepared by the Centerville School Board. She stressed the importance of renewing efforts to eliminate illegal drugs in the Centerville-Washington Township Community and prohibit the use of alcohol by minors. Mr. Compton explained the fact that at a recent meeting attended by City, Township and School officials, all agreed that the elimination and reduction of the use of illegal drugs and alcohol by minors is a Community effort and should be supported by all entities. Mrs. Beals pointed out that while this message is being sent to our youth and efforts are being made to keep schools safe, special attention must be given to the Constitution, Fourth Amendment Search and Seizure. She recognizes the intent of the proposed Resolution to search out and use the full extent of the Constitution in regards to probable cause. She expressed her concern that relationships law enforcement agencies have established with young people can be destroyed if not handled properly; officials must be mindful of the strict interpretation of the Constitution with probable cause being foremost.
