Following a recess in this meeting to provide for City Council to express appreciation to the award winners, the meeting reconvened into general session.

Mrs. McLaughlin announced the receipt of a letter of resignation from City Planning Commission member Stanley Swartz. Mr. Kingseed moved that the resignation of Stanley Swartz as a member of the City Planning Commission be accepted with regret. Mr. Singer seconded the motion. The motion passed unanimously.

Mrs. McLaughlin announced the receipt of a letter of resignation from Centerville Arts Commission member Carolyn Meininger. Mrs. Beals moved that the resignation of Carolyn Meininger as a member of the Centerville Arts Commission be accepted with regret. Mr. Stone seconded the motion. The motion passed unanimously.

Mayor Heintz announced the issuance of the following Proclamation:

The month of October as National Arts and Humanities Month in the City of Centerville.

Mayor Heintz outlined State Issue 2 that is up for renewal by the electorate on November 7, 1995. Issue 2 allows the state to use their bonding capacity to lend money to areas in the entire state, and also to contribute money for major projects, such as road projects, waste water treatment plants, stormwater, etc. Centerville has received \$1.3 million from the state for the widening of Wilmington Pike and \$1.2 million toward the widening of State Route 48. Issue 2 does not increase taxes, and it has benefited the entire state from time to time.

Mr. Haverland reported the following during the City Manager's Report:
The leaf pick up schedule is published in the Town Crier. Leaves will be picked up throughout the City until December 7, 1995.

Centerville has a new publication for business owners: the Centerville Commerce. Mr. William Stamper, Centerville Economic Development Coordinator, is publishing this newletter monthly for Centerville business owners.

The Centerville Recycling Program for comingled recycleables continues to be a success. In addition, Centerville recycles newspapers. To have your newspapers recycled, place them in a paper bag or tie them with string and they will be picked up on your regularly scheduled waste collection pick up day. Currently, Centerville is receiving \$60 a ton for newspapers, which goes back into the Waste Collection Enterprise Fund.

Upon question of Mrs. Beals, Mr. Haverland explained that the leaves are composted by the City, and donated to a large leaf mulching, recycling operation just south of the City. The yard waste is picked up separately and taken to the Montgomery County Composting facility at the north incinerator.

The Public Hearing was held concerning an Appeal filed by Henry A. Harlamert on behalf of Irongate Manor Apartments, 128-144 Maple Avenue, against a decision

rendered by the Planning Commission during their Meeting on September 12, 1995. Mr. Schwab located the property on the map being situated south of Irongate Park Drive, west of Maple Avenue and north of Ridgeway Road, and zoned Architectural Preservation District. Mr. Schwab reviewed a plan submitted to the Board of Architectural Review which included three (3) storage buildings and one (1) garage, with a step down width of 20 feet on the west end to 15 feet on the east side, and a 5 foot side yard setback. The Board of Architectural Review approved the plan. A Variance Application was then submitted to Planning Commission which included a side yard setback variation of 0 to 2 feet 6 inches. The Plan submitted included a 3 module storage building and one (1) garage 20 feet in width, with no side yard setback variatnce required for the first module, a 2 feet 6 inch side yard setback for the second module and a 0 foot side yard setback for the 3rd module. The Staff recommended to the Planning Commission denying the side yard setback variance based upon not meeting the standards as outlined in the Ordinance for granting a variance. In addition, Staff recommended that if Planning Commission approved the variance request, a 1 foot 6 inch side yard setback be required due to the overhang on the proposed storage building's roof. The Planning Commission, by a vote of 5-1, denied the Application for a Variance.

Mr. Brad Lennon, Design Group Architects, 131 South Main Street, addressed Council concerning the aesthetics of the storage building. After further evaluation of the project, Mr. Lennon advised that they have decided to relinquish the 0 foot setback variance and request only the 2 feet 6 inch side yard setback.

Mrs. Lula Stephens, Manager of Irongate Manor Apartments, expressed that the residents of the apartment building and the neighbors are in favor of this project. In addition, Mrs. Stephens presented a petition signed by 54 residents of the apartments stating their support of the storage building being built.

Mr. Henry A. Harlamert, Applicant, advised that building the storage building was the request of the residents of the apartments. He also explained that the members of the Planning Commission were very supportive of the project, however, could not vote against the Zoning Ordinance passed by City Council. Mr. Harlamert explained that the adjoining property owner would deed the necessary land to him to eliminate the need for the 0 foot setback. In addition Mr. Harlamert agreed to comply with whatever the City Engineer recommended for drainage between the buildings.

Mayor Heintz and Mrs. Beals both encouraged all citizens to call the City of Centerville and file a complaint when unsightly conditions exist on someone's property or anywhere in the City.

Mr. Singer expressed concern over the narrow passageway the construction of this storage building creates, and suggested some type of closure at each end, such as a fence.

Mrs. Beals expressed concern over the narrow passageway in consideration of maintaining the back of the building, and in the collection of debris, harboring animals, etc.

Mr. Compton asked how many feet would exist between the new building and the existing building on the adjoining property, and if there was enough room to get between

them to do maintenance work. Mr. Lennon explained that at its narrowest point there were 7½ feet.

Mr. Harlamert outlined an alternative proposal. Possibly have the 3 modules and garage configurated into an "L" shape. This would eliminate the need for a side yard setback on 2 of the 3 modules. This would also shorten the narrow passageway.

Mr. Stone moved that the Variance Application submitted by Mr. Henry A. Harlamert be tabled until the next regular council meeting scheduled for November 20, 1995, which would give Mr. Harlamert time to discuss an easement with the adjoining property owner, and give him the opportunity to reconsider the location of the storage building and the garage. Mr. Compton seconded the motion. The motion passed by unanimous vote.

ORDINANCE NUMBER 22-95 MUNICIPAL CODE UPDATE

The Public Hearing was held concerning Ordinance Number 22-95. Mr. Haverland advised that this is the first annual update to codify all City Ordinances and appropriate Resolutions for inclusion in the Centerville Municpal Code and repeal any Ordinances in conflict with any new Ohio legislation that has been passed. Mr. Compton sponsored Ordinance Number 22-95, An Ordinance Approving The Editing And Inclusion Of Certain Ordinances And Resolutions As Parts Of The Various Component Codes Of The Codified Ordinances; Providing For The Adoption And Publication Of New Matter In The Updated And Revised Codified Ordinances; And Repealing Ordinances And Resolutions In Conflict Therewith. Mr. Kingseed seconded the motion. The motion passed by unanimous vote of City Council.
