Mr. Michael A. Frasca, Spring Street Studio, described the sculpture "The Record" to be constructed in front of the Centerville Library in 1996 commemorating the community's Bicentennial. The sculpture is approximately 22 feet high, 5 feet square consisting of 280 individual pieces of high fired ceramic; each completed brick will weigh approximately 2500 pounds. Mary Bolton, past Chairman of the Centerville Arts Commission, outlined for the listening audience accomplishments of Mr. Frasca throughout other areas of the State. Upon question of Mrs. Beals, Mr. Frasca explained the process which will take place for the construction of the sculpture with anticipated completion being in October, 1996.

The Public Hearing was held concerning Ordinance Number 33-95. A list will be developed by the City outlining those issues which the City requires to be done and those issues for which the City has no leverage for accomplishment. Mr. Quarin brought attention to the following two safety issues for the City's consideration: legislation to require fencing around ponds, and better direction reflectors on Alexandersville-Bellbrook Road at the entrance into Nestle Creek at Marwyck Drive.
