Mayor Heintz expressed appreciation to the Centerville Arts Commission for coordinating all the activities at Stubbs Park on the 19th day of June, 1994.

Mayor Heintz reminded the listening audience of the many activities to take place in the Centerville community over the 4th of July weekend. Information concerning these activities can be received at the Centerville Municipal Building and will be listed in other publications.

Mr. Horn reported the following during his City Manager's Report:

A brief update was given on the progress being made at the Yankee Trace Golf Course: the maintenance building is now complete; all 18 holes and the practice holes have been seeded; work continues on the practice green; and the construction of the clubhouse is underway. Weather permitting, the golf course will open in 1994.

Negotiations continue with Great Traditions as the Master Developer for the residential components in and around the Yankee Trace Golf Course. A meeting of City Council may be held on Monday, June 27, 1994 to authorize the signing of a Contract.

Monday, June 27, 1994 to authorize the signing of a Contract. City Staff members are coordinating City activities to take place during the Americana Festival.

The final layer of asphalt is currently being put in place on the extension of Clyo Road from Bigger Road to Wilmington Pike.

The detention basin at the Activity Center has been completed through excellent cooperation with the Centerville-Washington Park District.

The South Main Street improvement project is well underway and is on schedule with a completion date in November being anticipated.

A City of Centerville project has been approved for funding through the Economic Development Government Equity (EDGE) program: the program being the extension of South Suburban Road westerly to Clyo Road; construction to be completed in 1995. This will provide an additional way in and out for businesses located on South Suburban Road.

Mr. Horn expressed appreciation to all volunteers and City Staff who participated in the Centerville Arts Festival and the spring clean-up week in Centerville.

Mr. Haverland announced the untimely passing of Mr. Randy Young, a great contributor to the City of Centerville relative to publications from the Centerville Printcraft.

Mr. Horn outlined total estimated receipts and expenditures for the City of Centerville during calendar year 1995. Mr. Compton moved that the Tax Budget for 1995 be approved for submission to the Montgomery County Auditor. Mr. Singer seconded the motion. The motion passed unanimously.

### ORDINANCE NUMBER 15-94 ANNEXATION SPIRES PROPERTY

RESOLUTION NUMBER 39-94 INCOME TAX ALLOCATION

Mr. Horn reviewed a proposed Resolution to allocate Income Tax receipts in various funds received on and after June 1, 1994. This procedure occurs twice yearly. Mr. Horn reviewed the following allocations:

General Fund67.0 percentCapital Improvements Fund19.0 percentStreet Construction and Maintenance Fund6.9 percentRecreational Projects Funds3.0 percentUnvoted Debt Retirement Fund4.1 percent

Upon question of Mr. Singer, Mr. Horn advised that these allocations are consistent with the current City Budget. Mr. Singer sponsored Resolution Number 39-94, A Resolution Authorizing And Directing The Allocation Of Income Tax Receipts Received On And After June 1, 1994 Between The General Fund, Capital Improvements Fund, Street Construction And Maintenance Fund, Recreational Projects Fund And Unvoted Debt Retirement Fund Of The City Of Centerville, and moved that it be passed. Mr. Compton seconded the motion. The motion passed by unanimous vote of City Council.

#### **RESOLUTION NUMBER 40-94**

Mr. Horn reviewed a proposed Resolution pledging the City's cooperation with the Ohio Department of Transportation for the resurfacing of existing I-675; that portion in the City of Centerville for approximately 3.45 miles. In conjunction with this project sound barriers will be put in place along the north side of I-675 east of the Kindergarten Village. This improvement project is scheduled for the 1997 construction season. Requests have been submitted to the Ohio Department of Transportation for sound barriers to be placed in the vicinity of the Hidden Hills Subdivision. Mr. Kingseed sponsored Resolution Number 40-94, A Resolution Enacted By The City Of Centerville, Montgomery County, Ohio, In The Matter Of The Hereinafter Described Improvement And To Request Cooperation By The Director of Transportation, and moved that it be passed. Mr. Beasley seconded the motion. The motion passed by unanimous vote of City Council.

#### RESOLUTION NUMBER 41-94 STREET LIGHTS APD

Mr. Horn reviewed a proposed Resolution to provide for the installation of decorative street lights in the Architectural Preservation District by the Dayton Power and Light Company. Mr. Schwab outlined the work to be done in the Architectural Preservation District along with the installation of these street lights on Franklin Street from Main Street to Westerfield and the Walton House. Work will begin on July 5, 1994 and continue through the month of September. Mayor Heintz identified this as part of the Architectural Preservation District enhancement program. Upon question of Mr. Beasley, Mr. Horn advised that this is part of the City's contract for the furnishing of electric lights in the City of Centerville by the Dayton Power

#### RESOLUTION NUMBER 42-94 SPRING VALLEY ROAD

Mr. Horn reviewed a proposed Resolution authorizing the City to cooperate with Washington Township as the lead agency for a joint application for Issue 2 or Local Transportation Improvement Funds to improve Spring Valley Road. Proposed is the widening of Spring Valley Road from Main Street west to Yankee Street with the majority of the improvement being in Washington Township. The construction of a three lane roadway is projected in Washington Township with four lanes in the City of Centerville. Mr. Beasley sponsored Resolution Number 42-94, A Resolution Authorizing The City Manager To Cooperate With Washington Township As The Lead Agency For A Joint Application For Issue 2 Or Local Transportation Improvement Funds (LTIP) For The Spring Valley Road Improvement Project, and moved that it be passed. Mr. Singer seconded the motion. The motion passed unanimously.

#### RESOLUTION NUMBER 43-94 STREET STRIPING

Mr. Horn recommended that proposed Resolution Number 43-94, a Resolution to provide for the striping of streets in the City of Centerville be tabled for further review.
