Mayor Heintz brought attention to the ribbon cutting ceremony scheduled for Monday, July 25, 1994, in the Sugarcreek Plaza, in celebration of the completion of the Wilmington Pike improvement project. The ceremony will begin at 10:00 A.M.

Mayor Heintz reminded the listening audience of the free concerts held at the Amphitheater in the Leonard E. Stubbs Memorial Park every Thursday and Sunday evening during the summer months at 7:00 P.M., and the opening of "Theatre Under The Stars" in the Amphitheater on July 22, 1994 at 8:30 P.M.

Mayor Heintz announced the recent issuance of a Proclamation designating July 10, 1994 as "The Church of The Incarnation Parish Center Dedication Day" in the City of Centerville.

Mr. Horn reported the following during his City Manager's Report:

Expressed appreciation to all volunteers, the Americana Festival Committee, the Sister City Committee and all City Staff who were involved in the success of activities during the 4th of July weekend.

The widening of South Main Street in the City of Centerville has caused the removal of some trees, however every effort is being made to retain as many trees as possible. Landscaping and the replacement of trees will take place after completion of the project.

The position of Executive Director for Seniors, Inc. has been filled.

The placement of sand in the bunkers at the Yankee Trace Golf Course is being completed. All utilities are in place at the temporary clubhouse. The first nine holes should be open for play soon.

Upon question of Mayor Heintz, Mr. Horn advised that restoration in the Terrace Villa Plat made necessary due to area drainage improvements has been completed.

Mrs. Beals identified for the listening audience the charge of the Centerville Sister City Committee. She encouraged people to get involved in a person to person exchange program with residents in Centerville's Sister Cities Waterloo, Ontario Canada and Bad Zwischenahn, Germany.

#### ORDINANCE NUMBER 15-94 ANNEXATION

The Public Hearing was held concerning Ordinance Number 15-94. Mr. Horn reviewed this proposed Ordinance which provides for submission of a Petition to the Board of County Commissioners of Montgomery County for the annexation of a 0.958 acre tract of land located on the east side of Yankee Street and surrounded on three sides by the Yankee Trace Golf Course. This property has been purchased by the City of Centerville for incorporation into the golf course project. Code Section 709.14, and moved that it be passed. Mr. Singer seconded the motion. The motion passed unanimously.

Mr. Eric Townsend, 310 Village Square Road, was present at this meeting to urge City Council to consider repealing Sections 474.06 and 474.07 (a) and (c) of the Centerville Municipal Code relating to the riding of bicycles in the City of Centerville. Mayor Heintz informed Mr. Townsend that City Staff is currently reviewing this matter so that a fair and equitable solution can be found for the safety of all. Mr. Horn pointed out the fact that the provisions cited by Mr. Townsend have been contained in the Municipal Code for many years and perhaps should be revised.

#### RESOLUTION NUMBER 45-94 ANNEXATION

Mr. Horn reviewed a proposed Resolution in support of the annexation of approximately 8.22 acres of land from Washington Township to the City of Centerville. He located the property on a map, being situated along the west side of State Route 48, south of Sheehan Road. The property has good contiguity with the City of Centerville, close proximity to Centerville's municipal services, and has a common interest with properties to the north in the City. This is a 100% owner annexation. Mrs. Beals pointing out the fact that the property, though annexed to the City of Centerville, remains in Washington Township; Mr. Farquhar explained that the Resolution has been written to conform to the language contained in the Ohio Revised Code Section 709.031(B). Upon question of Mr. Beasley, Mr. Horn advised that the roadway width is not included in this annexation per the request of the Montgomery County Engineer. Mr. Farquhar outlined the process for the annexation of territory from the unincorporated area of Washington Township to the City of Centerville. Mr. Compton, recognizing the desire of the property owner to annex to the City, requested that the Washington Township Trustees take a broad look at this 100% owner annexation and not waste township dollars to appeal a decision of the Board of Commissioners of Montgomery County relative to this annexation petition. Mr. Kingseed also encouraged the Trustees to look favorably upon this proposed annexation. Mrs. Beals sponsored Resolution Number 45-94, A Resolution In Support Of The Proposed Annexation Of Property Containing 8.222 Acres More Or Less From Washington Township, Montgomery County, Ohio To The City Of Centerville, Montgomery County, Ohio Pursuant To The Requirements of Revised Code Section 709.031 (B) Ohio Revised Code, and moved that it be passed.
