Council interviewed City Beautiful Commission applicant Mary Cramer. Council concurred that said appointment be made during the next Council Meeting.

Mr. Horn recommended that the City of Centerville honor a request received from the South Metro Chamber of Commerce for financial support in the amount of \$300.00 to assist in printing of a quarterly report. Council concurred with said recommendation.

Mr. Horn suggested that Melissa Warheit, Executive Director of the Ohio Ethics Commission, be invited to discuss with Council and Board and Commission members "Conflicts of Interest". Ms. Warheit will be asked to be present at the April 12, 1993 Council Work Session. This portion of the meeting will begin at 7:30 PM.


Government Teacher Teresa Lonsbury and two students from the Centerville High School were present at this meeting to outline for Council competition they have participated in and will participate in at the National Bicentennial Competition on the Constitution and the Bill of Rights in Washington, D.C. Needed is financial assistance for 26 students to make this trip and represent Centerville, Montgomery County and the State of Ohio. Council concurred to contribute \$1,200.00 toward this cause.


Mayor Heintz reviewed a proposal offered by the National Trust for Historic Preservation, National Main Street Center, to provide technical assistance services to the City of Centerville. The cost of said proposal is \$4,835.00 which includes time, materials and expenses. Discussion followed relative to the involvement of business people in the center of town. Making reference to correspondence received from Sharma Stone and Rick Pavlak relative to this project, they will be informed about this service.

Mayor Heintz reviewed for Council a meeting she recently attended of the Ohio Municipal League Annexation Committee.

Discussion followed relative to levys being placed before the electorate this spring. Being placed on the ballot by Washington Township is a Fire Levy and a Recreation Levy. Concern was expressed by Councilmembers relative to the lack of use of the fire station located on Thomas Paine Parkway in the City of Centerville. A representative from the Township will be invited to attend the Council Meeting on April 19, 1993 to answer questions relative to the Recreation Levy. Information will also be included in the next issue of the Town Crier.

City Council reviewed the layout for the kitchen facility in the Yankee Trace Clubhouse.
