Proposed Ordinance Number 1-92, An Ordinance Amending Ordinance Number 14-85, An Ordinance To Establish Standards, Principles And Procedures To Regulate Stormwater Runoff From Earth Disturbing Activities Which Cause Or May Cause Adverse Impacts Of Accelerated Surface Water Runoff, Soil Erosion, Or Sediment Deposition, was reviewed by Council. Mr. Kenning pointed out the fact that this Ordinance fine tunes Ordinance Number 14-85. He identified some of the changes made between the two Ordinances. Mr. Singer, speaking as Chairman of the Stormwater Drainage Task Force, recognizes the proposed Ordinance as adding definitions, providing explanations and clarifying the intent.

Police Chief William Lickert, Lieutenant Bruce Robertson and Lieutenant Steve Walker were present at this meeting to give an overview of activities of the Centerville Police Department: what has been accomplished, where the Police Department is today, and where it is going in the future.

Discussion followed relative to the Montgomery County EDGE Program. Mr. Kenning updated Council on the status of other Municipalities involved in the law suit. The following two questions must be decided by the Centerville Council: Should Centerville take the decision of the Appeals Court relative to this Program to the Supreme Court, and should Centerville join the EDGE Program. Pros and cons were offered concerning these two questions. This item will be placed on the Council Work Session Agenda for Monday, February 17, 1992 for further discussion and decision.

Mr. Kenning advised that consideration has been given to retaining Attorney John Koverman as Legal Counsel for approvals necessary for the construction of the Centerville Golf Course Community. Mr. Kenning will acquire additional information as to Mr. Koverman's intent and report back to City Council.

Mr. Kenning advised that legislation has been received from the Ohio Department of Transportation for repair work to Loop Road. This will require the closure of Loop Road for 21 days. Consent is necessary from the City of Centerville, there is no cost to the City in this project.

Following discussion, Council concurred that the Mayor's Committee to Study Intergovernmental Issues communicate with Mr. Al Turner relative to the annexation of 36 acres of territory he owns near the golf course property.

Mrs. McLaughlin advised that terms will soon expire for four members of the City Beautiful Commission. Council concurred that Michael Battaglia, Phyllis Kinder, Charlene Martinovich and Myrlyn Meister be reappointed as members of this Commission. This will be an agenda item for the February 17, 1992 Council Meeting.
