Mr. Haverland explained for Council a proposal presented to the City of Centerville for the substitution of Pontiac Bonnevilles instead of the Buick Regals previously Bid. During the June 10, 1991 Council Work Session Meeting consideration was given to the acceptance of the lowest and best Bid for the purchase of two unmarked police cars submitted by Perkins Buick-Pontiac-GMC Truck, Inc. - two Buick Regals in the amount of \$28,472.00 with trade-in. Since that time, Regal orders have been canceled due to year end parts shortage and Perkins has offered the City of Centerville Bonnevilles instead of the Regals at the same Bid price of \$28,472.00. Discussion followed relative to the acceptance of this Bid or rebidding. The majority of Council concurred to move forward at this time with said purchase.

Mr. Haverland reviewed a recommendation made by City Engineer Hoffman relative to the Bid acceptance for Stubbs Park Sanitary Sewer and Water Main Improvements. In consideration of all Bids received:

Mr. Hoffman recommended acceptance of the lowest and best Bid submitted by Joel Lehmkuhl Excavating, Inc. in the amount of \$27,443.50.

Mr. Haverland advised that the Greene County Engineer has advertised for Bids for the Wilmington Pike at State Route 725 Intersection Improvement. The Greene County Commissioners have accepted the Bid submitted by TdM. Construction Company. Centerville's share in this project is slightly less than \$75,000.00.

Mr. Haverland advised that it is the opinion of Municipal Attorney Robert Farquhar that Membership on the Satellite Juvenile Court Administrative Board should be made by the Centerville City Council and the Washington Township Board of Trustees. Members to be appointed are Darryl Kenning, Robert Farquhar, Michael Morton, Robert Surdyk, and Nicholas Kuntz.

Mrs. McLaughlin advised that Mr. James Teske is interested in serving another year as Chairman of the Centerville Historical Commission. Council concurred that this item be added to the Council Meeting Agenda to be held this date.
