City Council interviewed the following applicants for appointment as members of the Centerville Arts Commission:

Council concurred that Mr. Riley and Mrs. Meininger be appointed to fill the two vacant positions on this Commission. Applications by Mrs. Spoor and Mrs. Williams will be held for consideration when another vacancy occurs.

Mr. Victor Green was present to give an interim report concerning the potential annexation of a portion of Washington Township to the City of Centerville. Council concurred to re-evaluate this project two weeks from this date.

Mr. Haverland reminded members of Council of the 25th Anniversary Party scheduled for the Centerville Historical Society Tuesday, September 24, 1991 to be held at the Sycamore Creek Country Club, beginning at 7:00 P.M.

Mayor Heintz advised that the structure located on North Main Street in front of the Activity Center has been purchased by the Centerville-Washington Park District. The building will be demolished to provide additional green space and improved visibility for the entrance into the Activity Center.

Mayor Heintz advised that correspondence has been drafted to the President of the Washington Township, Board of Trustees, accepting their invitation to meet with them in a joint work session. Council concurred that this meeting take place on November 4 or 11, 1991 if either of these dates are convenient with the Trustees.

Mayor Heintz briefed Council on a meeting she recently had

with the newly appointed Centerville City School Superintendent Frank DePalma. An item discussed during this meeting was the establishment of a Civil Service Commission for the Centerville Schools. City Staff will further review this matter with Mr. DePalma.

Discussion followed relative to positions open in the Centerville Police Department. Mr. Haverland agreed that City Staff step-up the recruitment process to fill these vacancies.

Mr. Looper cited locations of signs on major streets in the City of Centerville, which perhaps are in violation of the sign section of the Centerville Zoning Ordinance. He encouraged better enforcement of sign regulations especially in the Architectural Preservation District.

Discussion followed relative to a name for the Centerville Golf Course. Mr. Haverland advised that a name should be selected soon so that it can be used when the final plan for the golf course is presented to the public. Names and suggestions were as follows:


Yankee Trace Golf Course

Yankee Trail


Centerville Golf Course or Club
