Mr. Stone read the Certificate of Appreciation issued for the Armed Forces called to active duty.

Mayor Heintz gave her State of the City Address detailing activities during 1990 and projections for 1991.

SOUTH METRO INDUSTRIAL PARK SECTION ONE RECORD PLAN

Mr. Kenning reported on the Planning Commission Meeting held January 8, 1991. Mr. Schwab reviewed the Record Plan for South Metro Industrial Park, the proposed development of approximately 12.732 acres of land into 3 lots situated east of Bigger Road, north of Thomas Paine Parkway and south of I-675. The plan includes a public roadway north and east off Thomas Paine Parkway with the construction of sidewalk on both sides of the street. This roadway will eventually tie into either the extension of Clyo Road or Wilmington Pike. Mr. Schwab located the subject property on a map and defined adjacent land uses and zone classifications. This is one section of an overall 33.4 acre development approved as a Major Use Special Approval Application several months previous. The zoning of the property is I-PD, Industrial Planned Development. Stormwater runoff will be controlled by the construction of two detention basins with this first phase of development. The Planning Commission, by unanimous vote, recommended approval of this Record Plan to City Council subject to the following conditions:

1. The street name South Metro Parkway shall be changed to replace the designation of "Parkway" with another designation.

2. Detailed stormwater drainage calculations and plans incorporating retention and/or detention and erosion control during construction shall be approved by the City Engineer in accordance with the approved Major Use Plan.

3. In lieu of completion of the required improvements prior to recording of the plat, a Performance Bond in an amount acceptable to the City Engineer shall be posted by the developer with the City of Centerville.

4. A temporary turnaround shall be constructed at the terminus of South Metro Parkway. The design shall be subject to approval by the Engineering Department. The turnaround shall be removed when South Metro Parkway is extended.

5. The plans for water lines and fire hydrants shall be subject to the approval of the Washington Township Fire Department.

Mr. Schwab reviewed the favorable recommendation by the City Engineer for the approval of this Record Plan subject to the following:

1. Acceptable Subdivider's Agreement.

2. A Performance Bond to cover the public improvements (pavement, curbs, storm sewers, sidewalks, etc.) in the amount of \$238,000, of which \$31,000 is for sidewalks (if a separate sidewalk bond is not posted).

3. Inspection Fee in the amount of \$650.00. A one year Maintenance Bond will be required when the public improvements are completed and the Performance Bond release is requested. The amount of the Maintenance Bond will be determined at that time.

Mr. Dick Witt, Vice President of Woodley Development Company, explained their intent for entry into the development off Wilmington Pike or Clyo Road, not off Thomas Paine Parkway. Development should take place during the spring of this year.

Mrs. Beals moved that the Record Plan for South Metro Industrial Park, Section One, be approved as recommended by the Planning Commission and the City Engineer subject to all recommended conditions. Mr. Stone seconded the motion. A roll call vote resulted in seven ayes in favor of the motion.

### ORDINANCE NUMBER 1-91 ZONING ORDINANCE AMENDMENT TEXT NON-CONFORMING SIGNS

Mr. Schwab advised that the Planning Commission, by unanimous vote, recommended approval of Ordinance Number 1-91, An Ordinance Amending Ordinance Number 11-86, The Zoning Ordinance Of Centerville, Ohio, Enacting Revised Regulations For Non-Conforming Signs, In Accordance With The Provisions Of Chapter 713 Of The Ohio Revised Code. Mr. Compton moved that Ordinance Number 1-91, An Ordinance Amending Ordinance Number 11-86, The Zoning Ordinance Of Centerville, Ohio, Enacting Revised Regulations For Non-Conforming Signs, In Accordance With The Provisions Of Chapter 713 Of The Ohio Revised Code, be set for Public Hearing on March 18, 1991. Mr. Singer seconded the motion. A roll call vote resulted in seven ayes in favor of the motion.

Mr. Stone sponsored Ordinance Number 21-90, An Ordinance To Repeal Ordinance 25-89 In Its Entirety And To Make Appropriations For The Current Expenses And Other Expenditures Of The City Of Centerville, State Of Ohio, During The Fiscal Year Ending December 31, 1990, and moved that it be passed. Mr. Singer seconded the motion. A roll call vote resulted in seven ayes in favor of the motion.

the financial plan for 1991. He gave a complete overview of projected net income and expenditures for the coming year. He identified the Budget as an ambitious plan which reflects many hours of consideration and planning by City Council.

Mr. Singer, speaking as Chairman of the Council Finance and Long-Range Planning Committee, outlined the process by which this Budget has been developed for the City of Centerville.

Mr. Compton brought attention to the fact that real estate taxes collected for the City of Centerville have decreased while the level of services has improved over the past several years. Mrs. Beals pointed out the fact that Centerville's Income

Tax is an earnings tax, it is not levied upon investment or retirement income.

Mr. Compton sponsored Ordinance Number 23-90, An Ordinance To Make Appropriations For The Current Expenses And Other Expenditures Of The City Of Centerville, State Of Ohio, During The Fiscal Year Ending December 31, 1991, and moved that it be passed. Mr. Stone seconded the motion. A roll call vote resulted in seven ayes in favor of the motion.

#### ORDINANCE NUMBER 25-90 PERSONNEL

The Public Hearing was held concerning Ordinance Number 25-90. Mr. Kenning reviewed this proposed Ordinance which establishes pay grades and benefits for employees of the City of Centerville. Mrs. Beals sponsored Ordinance Number 25-90, An Ordinance To Repeal Ordinance Number 27-89 In Its Entirety, To Establish Class Titles, Pay Grades, Rates Of Pay, And Regulations For Employees Of The City Of Centerville, Ohio, and moved that it be passed. Mr. Compton seconded the motion. A roll call vote resulted in six ayes in favor of the motion, Mr. Stone voted no.

### ORDINANCE NUMBER 26-90 WASTE COLLECTION

The Public Hearing was held concerning Ordinance Number 26-90. Mr. Kenning reviewed this proposed Ordinance which raises the fee for commercial/industrial service from \$4.00 to \$5.00 per cubic yard and updates residential service from \$9.00 to \$12.50 beginning March 1, 1991. The proposed Ordinance also provides that commercial/industrial service be periodically adjusted to reflect any fees charged by Montgomery County for a disposal of refuse, and that this adjustment be made upon approval by City Council. An increase in the tipping fee charged by Montgomery County has made this service fee increase necessary. Mr. Stone sponsored Ordinance Number 26-90, An Ordinance Amending Chapter 50: Garbage And Refuse, Section 50.06: Fees, Of The Municipal Code For The City Of Centerville, Ohio, and moved that it be passed. Mrs. Beals seconded the motion. A roll call vote resulted in seven ayes in favor of the motion.

Mrs. Beals encouraged the listening audience to continue recycling; the difference of disposing of recycables and the tipping fee for the disposal of refuse is significant.

Mr. Singer sponsored Resolution Number 1-91, A Resolution Authorizing And Directing The City Manager To Execute An Agreement Between Washington Township And The City Of Centerville For The Establishment Of A Joint Satellite Juvenile Court, and moved that it be passed. Mr. Stone seconded the motion. A roll call vote resulted in seven ayes in favor of the motion.

RESOLUTION NUMBER 2-91 MEMBERSHIP IN CHAMBER OF COMMERCE

Mr. Kenning reviewed a proposed Resolution to provide for the payment of a membership fee of \$150.00 to the South Metro Chamber of Commerce. This membership payment will entitle the City of Centerville six to twenty-five memberships for Centerville Officials and employees of the City of Centerville. Mr. Compton sponsored Resolution Number 2-91, A Resolution Authorizing The Payment For Six To Twenty-Five Memberships In The South Metro Area Chamber Of Commerce For Officials And Employees Of The City Of Centerville, and moved that it be passed. Mr. Singer seconded the motion. A roll call vote resulted in six ayes in favor of the motion, Mr. Beasley voted no.

## RHOADS CENTER PERFORMANCE BOND RELEASE
