The Council of the City of Centerville, County of Montgomery, State of Ohio, met in Regular Session on Monday, February 19, 1990 at 8:00 P.M. in the Council Chambers of the Centerville Municipal Building. The Meeting was opened with an Invocation given by Reverend Preston Dawes, City Chaplain, and the Pledge of Allegiance to the Flag with Mayor Shirley Heintz presiding. Mr. Compton moved that the Minutes of the foregoing Meetings be approved as distributed. Mr. Beasley seconded the motion. The motion passed by unanimous vote; however Mr. Singer and Mrs. Beals abstained from the Minutes of the Meeting held January 29 and Mayor Heintz from the Meeting held February 12.

Mrs. McLaughlin announced the receipt of a letter of resignation from Centerville Property Review Commission Member C. Mark Kingseed. Mrs. Beals moved that the resignation of C. Mark Kingseed as a Member of the Centerville Property Review Mr. Singer seconded the motion. Commission be accepted. motion passed unanimously.

Mr. Edwin Kovar, Executive Director, was present at this Meeting to outline for Council services to be provided to our Community by the Miami Valley Emergency Management Authority. Emergency services are those previously performed by Civil Defense and Disaster Services. The name change necessitates the execution of a new Agreement between the City of Centerville and the Miami Valley Emergency Management Authority. Mr. Kovar outlined the make-up of the Executive Board, and equipment and facilities available for the operation of the Authority. Municipalities are required by Ohio Law to either form their own emergency management or enter into an Agreement with a regional Minutes of

authority. Upon questions of City Council, Mr. Kovar explained their role in a Community when an emergency situation occurs.

Mayor Heintz advised that Centerville has been named Tree City USA for 1989. Centerville has held this distinction over the past several years. This is a result of the efforts put forth by the City Beautiful Commission.

Mr. Kenning reported that Centerville has received from the United Way the traveling plaque for Southern Montgomery County, Township, City, Village, contributing the largest percentage increase per employee to the United Way.

Upon question of Mayor Heintz, Mr. Kenning advised that work on the South Main Street, Spring Valley Road Improvement, should begin approximately March 12, 1990.

RESOLUTION NUMBER 3-90 EMERGENCY MANAGEMENT

Mr. Kenning recommended that the City of Centerville enter into an Agreement with the Miami Valley Emergency Management Authority to provide emergency management and civil defense services to the City of Centerville. Mr. Compton sponsored Resolution Number 3-90, A Resolution Authorizing And Directing The City Manager To Execute An Agreement Between The City Of Centerville And The Miami Valley Emergency Management Authority, and moved that it be passed. Mrs. Beals seconded the motion. The motion passed unanimously.

CENTERVILLE PROPERTY REVIEW COMMISSION

Mr. Singer moved that Mr. Gary Huff be appointed as a Member of the Centerville Property Review Commission to fill the vacancy created by the resignation of Mr. C. Mark Kingseed. Mr. Beasley seconded the motion. The motion passed by unanimous vote of City Council.

ORDINANCE NUMBER 3-90 PICKETING

Mr. Kenning briefly reviewed a proposed Ordinance to prohibit picketing in residential areas in the City of Centerville. This legislation is similar to that which has been passed by neighboring Municipalities. Mrs. Beals moved that Ordinance Number 3-90, An Ordinance Enacting Section 509.09 Of The Codified Ordinances Of The City Of Centerville Regulating Residential Picketing, be set for Public Hearing on March 19, 1990. Mr. Compton seconded the motion. The motion passed unanimously.
