#### RESOLUTION NUMBER 5-90 RECREATIONAL PROJECTS FUND

Mr. Kenning reviewed proposed Resolution Number 5-90, A Resolution to establish a Recreational Facilities Fund. Establishment of this Fund is necessary to provide for the deposit and disbursement of money for recreational projects. Mr. Compton sponsored Resolution Number 5-90, A Resolution Establishing A Recreational Projects Fund, and moved that it be passed. Mr. Singer seconded the motion. The motion passed unanimously.

#### RESOLUTION NUMBER 6-90 RECREATIONAL FACILITIES

Mr. Kenning reviewed a proposed Resolution requesting the Fiscal Officer of the City of Centerville to certify estimated maximum maturity of Bonds and Notes to pay part of the cost of acquiring real property for municipal recreational facilities. Mrs. Beals sponsored Resolution Number 6-90, Resolution Requesting Fiscal Officer To Certify Estimated Maximum Maturity Of Bonds And Notes, and moved that it be passed. Mr. Compton seconded the motion. The motion passed by unanimous vote.

### ORDINANCE NUMBER 7-90 RECREATIONAL FACILITIES

Mr. Kenning reviewed a proposed Ordinance to authorize the issuance of \$5,900,000.00 Bond Anticipation Notes in order to pay part of the cost of acquiring real property for municipal recreational facilities for the City of Centerville. This Ordinance is an emergency measure due to the fact that quotes are not available far enough in advance for regular legislation. Notes to be dated April 30, 1990 will bear interest at the rate of 6.49 percent per annum.
