## RESOLUTION NUMBER 15-90 RECREATIONAL FACILITIES

Mr. Kenning reviewed a proposed Resolution requesting the Fiscal Officer of the City of Centerville to certify estimated maximum maturity of Bonds and Notes to pay part of the cost of acquiring real property for municipal recreational facilities. This is the enabling legislation to borrow additional revenue for the final acquisition of property for the golf course project. Mrs. Beals sponsored Resolution Number 15-90, Resolution Requesting Fiscal Officer To Certify Estimated Maximum Maturity Of Bonds And Notes, and moved that it be passed. Mr. Singer seconded the motion. The motion passed by unanimous vote.

## ORDINANCE NUMBER 8-90 RECREATIONAL FACILITIES

Mr. Kenning reviewed a proposed Ordinance to authorize the issuance of \$2,335,000.00 Bond Anticipation Notes in order to pay part of the cost of acquiring real property for municipal recreational facilities for the City of Centerville. This Ordinance is an emergency measure due to the fact that quotes are not available far enough in advance for regular legislation. Notes will be dated April 30, 1990 and will bear interest at the rate of 6.73 percent per annum. Mr. Singer sponsored Ordinance Number 8-90, Ordinance Authorizing The Issuance Of \$2,335,000 Of Bond Anticipation Notes Of The City Of Centerville, Ohio, For The Purpose Of Paying Part Of The Cost Of Acquiring Real Property For Municipal Recreational Facilities And Paying Costs Incident Thereto, To The Improvement Thereof, And To The Issuance Of Bonds, Or Notes Issued In Anticipation Thereof, And Declaring An Emergency, and moved that it be passed. Mr. Compton seconded the motion. The motion passed unanimously.
