RESOLUTION NUMBER 1-89 CAPITAL IMPROVEMENT PROGRAM

Mr. Kenning advised that a Resolution adopting the 1989-1993 Capital Improvement Program for the City of Centerville must be submitted when applying for Issue 2 Funds for Public Infrastructure Capital Improvements. Action is necessary this date in order that submissions may be made on Friday, January 13, 1989.
