RESOLUTION NUMBER 10-87 CLYO ROAD EXTENSION

Mr. Kenning reviewed the following Bids received for the issue of Clyo Road Improvement Special Assessment Bonds of the City of Centerville, in the principal amount of \$207,350.00. dated May 1, 1987:

Mr. Kenning recommended acceptance of the Bid submitted by Merit Financial Corporation. Mr. Taylor sponsored Resolution Number 10-87, A Resolution Approving Acceptance By The Director Of Finance Of The Highest Bid For The Issue of \$207.350 Clyo Road Improvement Special Assessment Bonds Of The City And Approving Selection Of And Agreement With Bond Registrar, and moved that it be passed, awarding the Bid of Merit Financial Corporation at an interest rate of 6 3/8% and a premium of \$167.50. Mr. Stone seconded the motion. The motion passed by unanimous vote of City Council.

Mr. Kenning recommended acceptance of the Bid submitted by T.d.M. Construction Company, Inc. in the amount of \$347.306.00 for the City's annual contract street repair program for 1987 including installation of some sidewalk and bikeways. He further recommended that the Bid be extended up to \$535,000.00 in consideration of the favorable rates for asphalt available at this time. Mayor Heintz pointed out the fact that the asphalt portion of the Bid submitted by T.d.M. was lower than the other three Bids received. Mr. Kenning advised that by extending this Bid to \$535,000.00 via T.d.M., additional streets can be resurfaced and repaired. Mr. Taylor sponsored Resolution Number 11-87, A Resolution Accepting The Bid Of T.d.M. Construction Company, Inc., For A Road Improvement Program 1987 In The City Of Centerville And to Authorize The City Manager to Enter Into A Contract In Connection Therewith, and moved that it be passed and that the expenditure up to \$535,000.00 be authorized in accordance with the unit price bid by T.d.M. Construction Company. Mr. Stone seconded the motion. The motion passed unanimously.

RESOLUTION NUMBER 12-87

Mr. Kenning reviewed a request made to the Montgomery County Auditor for an advance of \$150,000.00 out of the current collection of real estate taxes assessed and collected on behalf of the City of Centerville. This procedure has customarily been done over the past several years. The request has been made and monies received. Mr. Siler sponsored Resolution Number 12-87, A Resolution Ratifying The Request Of An Advance Of One Hundred Fifty Thousand Dollars (\$150,000.00) Out Of The Current Collection Of Real Estate Taxes Assessed And Collected On Behalf Of The City Of Centerville, and moved that it be passed. Mr. Taylor seconded the motion. The motion passed by unanimous vote.
