Mr. Forest Swift, Executive Director of RTA, was present to review with Council the current bus transportation system, what to expect in 1987 and what is projected for the year 2,000. He solicits comments to the following questions:

1. What usage should be required to establish a route?
2. What farebox receipt ratio should be maintained?
3. Should service be provided with few service providers?

Police Chief Lickert explained to Council the fact that if an interstate traverses through a Municipality, that Municipality is responsible for traffic control on that portion within the corporation limits. However, the Municipality may request that traffic be controlled by the State Patrol. He defined the portion of I-675 within Centerville to be approximately 2 1/2 to 3 miles in length. He outlined pros and cons with the Centerville Police Department providing traffic control on I-675:

Cons - officers will be exposed to increased speed, traffic accidents different from that which they are accustomed which will require longer investigations, and high speed chases.

Pros - the city can determine traffic policies and how they can be controlled, reduced response time, and in emergency situations there will be no question who is responsible for service.


Chief Lickert indicated his preference with Centerville assuming traffic control on I-675. Mr. Taylor suggested that information be obtained to determine what neighboring Municipalities are doing in the same situation as Centerville. Mr. Kenning will obtain this information and report to Council at a future Council Work Session Meeting.

Signage at the entrance into Bethany Lutheran Village was briefly discussed by Council. The majority of Council concurred that this matter be resolved by the City Manager.

Mrs. McLaughlin distributed to Council an investigation report concerning the Application for the transfer of a D5 and D6 Liquor Permit from Centerville Club Inc. to Far Oaks Enterprises Inc., DBA Centerville Club, 6290 Far Hills Avenue. Council indicated no objection to the transfer of said Permit.

Mrs. McLaughlin distributed to Council an investigation report concerning the Application for the transfer of a D1, D2 and D6 Liquor Permit from Vi X & Binh T Quach & Ruth I Wells & Lynn Y S & Lizbie G S Lin to North China Inc., DBA Dragon Palace, 6090 Far Hills Avenue. Council indicated no objection to the transfer of this Permit as requested.
