Mrs. McLaughlin announced the receipt of a letter of resignation from City Beautiful Commission Member Susan Stiller which became effective January 8, 1985.

Mrs. McLaughlin also advised of a letter received from Seniors, Inc., extending their appreciation to the City of Centerville for the City's generous financial support for 1985.

Mayor Heintz gave her "State of the City" address for 1985. She recognized accomplishments and contributions made by City Council, City Staff, Board and Commission Members and volunteers of the City of Centerville. She outlined on-going programs and projects proposed for the year 1985 and stressed open communications with other entities and all residents of the area.

ST. LEONARD CENTER, INC. CONDITIONAL USE

Mr. Kenning reviewed the Planning Commission Meeting held December 18, 1984. The Planning Commission recommended approval of a Conditional Use Application submitted by St. Leonard Center, Inc., to construct 86 dwelling units on approximately 14 acres of land at the southeast corner of their property at 8100 Clyo Road. Mr. Singer moved that the Conditional Use Application submitted by St. Leonard Center, Inc. be set for Public Hearing before Council on February 18, 1985. Mr. Compton seconded the motion. The motion passed unanimously.

Mr. Samples, speaking as Chairman of the Zoning Task Force, gave a brief progress report on their review of the Zoning Ordinance, this task has been divided into three phases, the first is nearly complete. As each phase is completed it will be made available to City Council and the Planning Commission for review.

ORDINANCE NUMBER 49-84 APPROPRIATIONS 1984

The Public Hearing was held concerning Ordinance Number 49-84. Mr. Kenning reviewed this proposed final appropriation Ordinance for 1984 totaling \$5,585,695.00. Mr. Siler sponsored Ordinance Number 49-84, An Ordinance To Repeal Ordinance 35-83 In Its Entirety To Make Appropriations For Current Expenses And Other Expenditures Of The City Of Centerville, State Of Ohio, During The Fiscal Year Ending December 31, 1984, and moved that it be passed. Mr. Taylor seconded the motion. The motion passed by unanimous vote of Council.

ORDINANCE NUMBER 51-84 STREET LIGHTS

The Public Hearing was held concerning Ordinance Number 51-84. Mr. Kenning reviewed this proposed Ordinance authorizing the Dayton Power and Light Company to provide street lights in the City of Centerville through December 31, 1986. The Ordinance also provides that the Contract may be extended by mutual consent and it includes a 5 percent rate increase per year. This legislation is the result of lengthy negotiations between the Miami Valley Cable TV Council and the Dayton Power and Light Company. Mr. Compton sponsored Ordinance Number 51-84, An Ordinance Fixing The Price Which The Dayton Power And Light Company, Its successors And Assigns, May Charge For Electric Light Furnished To The Public Grounds, Streets, Lanes, Alleys And Avenues In The City Of

Centerville, State Of Ohio, For A Period Of Twenty-Four Months Commencing On The 1st Day Of January 1985, And Ending On The 31st Day Of December 1986, And Determining The Manner In Which Said Lighting May Be Furnished, Provided And Paid For, and moved that it be passed. Mr. Singer seconded the motion. The motion passed unanimously.

ORDINANCE NUMBER 2-85 PERS PPF

The Public Hearing was held concerning Ordinance Number 2-85. Mr. Kenning reviewed this proposed Ordinance which provides that the City of Centerville pick up 6 of the 8 1/2 percent which employees pay into the Public Employees Retirement System or the Police and Firemen's Disability and Pension Fund. This Ordinance amends Ordinances 44-84 and 45-84 to satisfy requirements of the Internal Revenue Service. Mr. Taylor sponsored Ordinance Number 2-85, An Ordinance Amending Ordinances 44-84 And 45-84 By Amending The Effective Date Said Ordinance Commences And By Placing Additional Restrictions On The Plan Established By Said Ordinance, and moved that it be passed. Mr. Siler seconded the motion. The motion passed unanimously.

Mr. William Wuest, 1454 Carriage Trace Boulevard, appeared before Council to reinforce the need of a traffic signal at the entrance into the Carriage Trace Condominium Development on Bigger Road. Mr. Kenning reviewed evaluations presently being made relative to this problem. He will supply additional information to Mr. Wuest as it becomes available.

RESOLUTION NUMBER 1-85 TAX RATES

Mr. Kenning reviewed a proposed Resolution accepting tax rates as determined by the Montgomery County Budget Commission; the total mileage which the City of Centerville receives being 3.56. Mr. Taylor sponsored Resolution Number 1-85, Resolution Accepting The Amounts And Rates As Determined By The Budget Commission And Authorizing The Necessary Tax Levies And Certifying Them To The County Auditor, and moved that it be passed. Mr. Samples seconded the motion. The motion passed by unanimous vote.

RESOLUTION NUMBER 2-85 ALCOHOLISM

Mr. Kenning reviewed this proposed Resolution to authorize a Contract with the Combined Health District of Montgomery County, that the City of Centerville contribute 10 percent of its funds received from the State of Ohio from Liquor Permit Fees to the Health District for the prevention, treatment and rehabilitation of alcoholism and alcoholics. Mr. Samples sponsored Resolution Number 2-85, A Resolution Authorizing And Directing The City Of Centerville To Enter Into An Agreement With The Combined Health District Of Montgomery County Concerning Establishment Of A Rehabilitation Program For The Prevention Of Alcoholism And For The Treatment And Rehabilitation Of Alcoholics And Providing For The Payment Of Fees, and moved that it be passed. Mr. Compton seconded the motion. The motion passed unanimously.
