The Council of the City of Centerville, County of Montgomery, State of Ohio, met in Regular Session on Monday, March 19, 1984 at 8:00 P.M. in the Council Chambers of the Centerville Municipal Building. The Meeting was opened with an Invocation given by Councilman James Singer, and the Pledge of Allegiance to the Flag with Mayor Shirley Heintz presiding. Mayor Heintz introduced Mr. Ralph Bender, Coach of the Speech and Debate Team of which these students are members.

Mr. Samples returned to the Meeting at this time.

A Proclamation issued by Mayor Heintz was read by Mr. Compton designating March 18-24, 1984 as Poison Prevention Week in the City of Centerville.

Mr. Stone read a Proclamation issued by Mayor Heintz designating March 21, 1984 as Single Parent Day in the City of Centerville.

Mr. Kenning, during his City Manager's Report, advised that through Centerville's constant determination with the State of Ohio, motor vehicle registrations have been brought up to date, thus increasing Centerville's shared revenue from the State of Ohio, categorized as Motor Vehicle Fund.

#### K-MART CORPORATION

Mr. Kenning reviewed the Planning Commission Meeting held March 6, 1984. Mr. Schwab reviewed for Council a request submitted by the K-Mart Corporation to locate a temporary garden center adjacent to the present K-Mart Store located at the northeast corner of State Route 48 and Spring Valley Road. The time period requested extends from April 1 to July 15, 1984. The Planning Commission, by unanimous vote, recommended approval of this request to City Council. Mr. William Baney, Manager of the store in question, was present to answer any questions concerning his proposal. Mr. Taylor moved that the request submitted by the K-Mart Corporation for a temporary garden center to be located adjacent to their present building on South Main Street, be approved in accordance with the recommendation of the Planning Commission. Mr. Siler seconded the motion. A roll call vote resulted in seven ayes in favor of the motion.

# HARTZELL FLOWERS

Mr. Schwab reviewed a request submitted by Hartzell Flowers to erect a temporary garden center in the Centerville Place Shopping Center. The proposed location being the southwest corner of State Route 48 and the main access into the Shopping Center. This proposal includes a greenhouse and a tent, the time period being from April 15 to July 1, 1984. The Planning Commission unanimously recommended approval of this request to City Council with the following conditions:

The proper permits be obtained from the Building Inspection Department and Fire Department.

2. The flower beds as shown on the proposed layout maintain a 10 foot setback from the main entrance driveway.

Mr. Tom Hartzell, representing the Applicant, explained their proposal: plants are locally grown, the greenhouse will be new and measures 20 feet by 48 feet, while the tent measures 20 feet by 20 feet. The greenhouse is of steel structure with a plastic covering.

Mr. Rick Hungerford, Legal Counsel for Beerman Realty, defined the use of the greenhouse to protect the flowers and provide shelter for customers,

he supported approval of this request.

Mr. Stone moved that the request submitted by Hartzell Flowers to erect a temporary garden center in the Centerville Place Shopping Center be approved in accordance with the recommendation of the Planning Commission including the

two stated conditions. Mr. Samples seconded the motion. A roll call vote resulted in six ayes in favor of the motion; Mayor Heintz voted no.

### WALNUT HILLS ESTATES II SECTION TWO

Mr. Schwab reviewed the Record Plan for Walnut Hills Estates II, Section Two, located at the extension of Rhine Way in the Walnut Hills Subdivision. This plan includes 13 lots which would provide a total of 30 lots in the overall development. The Preliminary Plan for Walnut Hills Estates II was approved as a Planned Unit Development with a total of 29 lots. The Planning Commission unanimously recommended approval of this Record Plan subject to the following conditions:

1. Lot 30 be eliminated by combining it with Lot 29.

2. A 10 foot wide public access walkway easement must be dedicated between Lots 18 and 19. A 2 foot wide concrete walkway must be constructed by the developer in this easement. This public access easement must be labeled on the Record Plan drawing and described in the plat dedication.

3. The City will permit the developer to record a deed acquiring the entire 7,351 acre tract with the condition that the developer must immediate-

ly thereafter record this Record Plan with Montgomery County.

4. The protective covenants be changed as noted on the attached copy of the covenants.

- 5. The easement between Lots 18 and 19 on the Record Plan be changed to match the easement shown on the Construction Drawings attached to this Record Plan.
- The street name Sycamore View be changed to Sycamore View Court.
   In lieu of completion of the public improvements prior to recording of the plat, the applicant must enter into a Subdivider's Agreement with the City and post a Performance Bond in a dollar amount approved by the City Engineer.

Mr. Kenning reviewed the Staff recommendation which set the amount of the Performance Bond at \$72,000.00 and the Inspection Fee at \$337.70. Mr. Compton moved that the Record Plan for Walnut Hills Estates II, Section Two, be approved in accordance with the recommendation of the Planning Commission including all recommended conditions and the recommendation of the City Staff. Mr. Siler seconded the motion. A roll call vote resulted in seven ayes in favor of the motion.

### HSIEN-MING MENG

Mr. Kenning reviewed the Conditional Use Application submitted by Hsienming Meng to provide for a private club at 2240 East Alexandersville-Bellbrook Road in the City of Centerville. Mr. Taylor moved that the Conditional Use Application submitted by Hsien-ming Meng for a private club at 2240 East Alexandersville-Bellbrook Road be set for Public Hearing on April 16, 1984. Mr. Siler seconded the motion. A roll call vote resulted in seven ayes in favor of the motion.

Mr. Kenning reviewed the establishment of a Group Home Ordinance Review Committee in 1983. This Committee has met several times and has submitted their recommendation to the Planning Commission. The Planning Commission has, in turn, recommended certain procedural changes to City Council. Mayor Heintz advised that this Report will be reviewed in detail by Council during a future Council Meeting.

Mr. Singer reported that the Drainage Task Force Committee has submitted a report to City Council and the Committee looks forward to it being considered by Council during a Council Work Session Meeting. Mayor Heintz thanked Councilman Singer and the Members of the Task Force for a very comprehensive report. This item will be discussed during the next Council Work Session Meeting.

#### ORDINANCE NUMBER 6-84 CODE OF ETHICS

The Public Hearing was held concerning Ordinance Number 6-84. Mr. Kenning reviewed this proposed Ordinance which deletes the requirement that a public official disclose on record the nature and extent of the private interest when a conflict exists or may be perceived to exist in dealing with public matters. Mr. Singer pointed out the fact that this requirement was originally adopted merely to encourage a public official to state the nature if he/she was comfortable in so doing, it was felt that perhaps Members of City Council should from time to time know the nature of a conflict. Mr. Samples also pointed out that this amendment in no way eliminates the requirement for a public official to excuse himself from that portion of a meeting where a conflict exists. Mr. Siler sponsored Ordinance Number 6-84, An Ordinance Amending Ordinance Number 51-79, An Ordinance Which Enacted Sections Of Chapter 121 Of The Centerville Municipal Code To Approve, Adopt And Enact A Code Of Ethics For Elected And Appointed Public Officials Of The City Of Centerville, and moved that it be passed. Mr. Taylor seconded the motion. A roll call vote resulted in seven ayes in favor of the motion.

#### ORDINANCE NUMBER 7-84 PERSONNEL APPEALS BOARD

The Public Hearing was held concerning Ordinance Number 7-84. Mr. Samples sponsored Ordinance Number 7-84, An Ordinance To Appoint Charles P. Brown To The Personnel Appeals Board For The City Of Centerville, Ohio, And Establish A Term Of Office, and moved that it be passed. Mr. Compton seconded the motion. A roll call vote resulted in seven ayes in favor of the motion.

#### ORDINANCE NUMBER 8-84 BOARD OF ARCHITECTURAL REVIEW

Mr. Taylor moved that Ordinance Number 8-84, An Ordinance To Appoint Phyllis B. Brooks To The Board Of Architectural Review For The City Of Centerville, Ohio, And Establish A Term Of Office, be set for Public Hearing on April 16, 1984. Mr. Siler seconded the motion. A roll call vote resulted in seven ayes in favor of the motion.
