The Council of the City of Centerville, County of Montgomery, State of Ohio, met in Regular Session on Monday, February 21, 1983 at 8:00 P.M. in the Council Chambers of the Centerville Municipal Building. The Meeting was opened with an Invocation given by Reverend Preston Dawes, Pastor of the Heritage United Presbyterian Church and City Chaplain, and the Pledge of Allegiance to the Flag with Mayor J. V. Stone presiding. Councilmembers and City Staff present were as follows:

Mayor Stone advised that Councilman Jeffrey Siler has requested that he be excused from this Meeting. Mr. Taylor moved that Mr. Siler be excused from this Meeting. Mrs. Heintz seconded the motion. A roll call vote resulted in six ayes in favor of the motion.

Mr. Singer moved that the Minutes of the foregoing Meetings be approved, as distributed. Mr. Sweetman seconded the motion. A roll call vote resulted in six ayes in favor of the motion; however, Mayor Stone abstained from the Minutes of the Meetings held February 7, 1983.

Mayor Stone read and presented a Certificate of Recognition to Lisa Specht and Kathleen Kronauge for their election to the National All-America Soccer Team; both are members of the Archbishop Alter Girls High School Soccer Team; Lisa resides in the City of Centerville and Kathleen in Washington Township.

Mayor Stone outlined for the listening public, accomplishments made in the City of Centerville during the year 1982. Construction has begun on Interstate 675 after many years of delay. State Route 725 will be improved as rapidly as possible, encouraged by concentrated efforts of City Officials during 1982. A million dollar street improvement project has been instituted in the City of Centerville, through income tax dollars approved by the electorate of the City of Centerville. Major equipment has been purchased and old equipment refurbished for street repairs and maintenance. Mayor Stone reviewed Council and Staff representation in various Local, Regional, State and National Organizations. A Council Outreach Program has been reinstated whereby City Officials meet with business leaders and professional leaders in the Community to review mutual concerns. City Council has also met with City Boards and Commissions in an effort to acquire a better relationship between both parties. Planning Commission Meetings are now on cablecast. Mayor Stone pointed out the fact that new construction in the

center of town has been approved by City Council to be in the best interest of the entire Centerville Community. Centerville's Sister City Program has been very active during 1982. A Sister City Association has been Incorporated and anyone with interest can become a Member of this Association. City Council in 1982, continued to support Community Organizations. Centerville participated in the organization of a Senior Citizens Center at St. Leonards. The City is actively engaged in the preparation and distribution of a promotional brochure for the Centerville-Washington Township area. Centerville continues to improve the Wright House in the center of town and participates fully with the Centerville-Washington Township Chamber of Commerce in the Americana Festival. Mayor Stone reviewed new approaches taken in 1982 relative to the purchase, repair and maintenance of capital equipment. The City has developed a self-funded Insurance Program for the employees of the City of Centerville, constituting a cost savings to the City and to the taxpayers. A Zoning Task Force has been appointed to completely review and revise as necessary the City's current zoning regulations to provide better service to Centerville citizens. Centerville continues to cooperate with surrounding Municipalities to make operations effective but less expensive. Mayor Stone thanked the citizens of Centerville, the City Staff and City Council for Centerville's stability and progress during 1982.

Mr. Kenning reported the following during his City Manager's Report: The street sweeper is being refurbished and will be back in operation within 4 to 6 weeks.

The four wheel drive vehicle purchased for use in the Police Department has been delivered to the City of Centerville.

Bids have been advertised for a new telephone system in the Centerville Municipal Building, for an Insurance Package and for an asphalt paving machine.

Bids will soon be advertised for the purchase of a computer for the City of Centerville.

Mr. Sweetman announced the kick off for the new health channel on Cable TV, scheduled for Thursday, February 24, 1983.

Mr. Sweetman complimented Mayor Stone for his outstanding leadership in the Community during the year 1982.

CENTERVILLE PLACE SHOPPING CENTER

Mr. Kenning advised that the Beerman Realty Company has requested that the Site Plan Amendment submitted for the Centerville Place Shopping Center be tabled for further consideration. Requested is a permit to erect a Green Machine for Third National Bank in the parking area just south of the Citizens Federal Savings building. Mr. Singer moved that the Site Plan Amendment submitted for the Centerville Place Shopping Center to erect a Green Machine for Third National Bank be tabled. Mr. Taylor seconded the motion. A roll call vote resulted in six ayes in favor of the motion.
