Chief Randolph reviewed for Council a proposed DUI (Driving Under Influence) Ordinance for the City of Centerville. He suggested that this matter be discussed at a later date when more information is available. Council concurred to discuss this proposal at a future Council Work Session Meeting.

Mr. Sweetman presented to Council a copy of an Ordinance enacted by the City of Huber Heights to require persons riding mopeds to wear helmets. He suggested that Centerville consider passage of similar legislation. The language of the sample Ordinance will be clarified and presented to Council for further consideration. Discussion followed relative to requiring certain equipment on bicycles, this matter will be further discussed at a later date.

Mr. Bishop reviewed asphalt paving projections by the City of Centerville during 1983. If the asphalt paving machine recently Bid is purchased, the City can perform some of the jobs at a little less cost than on a Contract basis. This equipment is estimated to last 20 years; over this period of time cost savings will continue to rise as the machinery is utilized more and more by City crews. Mr. Sweetman suggested that perhaps consideration should be given to the purchase of other Capital equipment before this Bid is accepted. Following discussion relative to the use of this equipment as much as possible and perhaps leasing it for use by other Municipalities, the majority of Council concurred to purchase said equipment. Acceptance of the Bid will be an agenda item for the April 4, 1983 Council Meeting.

Council discussed the reorganization of the Community Fiscal Analysis Committee. Mayor Stone advised that a suggestion was made to reduce the Membership on said Committee and that it be supported by task forces as necessary. Council concurred that the Membership be reduced in size and that a new Chairman be appointed.

Mr. Kenning reviewed a proposed Health Insurance Incentive Program designed to financially benefit those employees not using the Health Insurance or using it on a less degree. The City as well as the employee will benefit from this program; both will share in the savings. Council concurred with the program as designed.

Mr. Bormet reviewed a proposed Sick Leave Conversion Plan for employees at time of retirement. He submitted four options for Council's consideration. Council concurred to discuss this matter at a future Council Work Session Meeting.

Mr. Sweetman cited problems with the interpretation of the Fire Code for the City of Centerville vs. Washington Township. He suggested that the City prepare details concerning the interpretation of the Code in Centerville and this be available for all interested Contractors; the Code is being interpreted by City Officials differently than by Officials of Washington Township and Montgomery County. Mr. Kenning will further research this matter.
