Mrs. McLaughlin advised that Sister City Applicant Suzanne Pirie prefers to wait for an appointment on the Sister City Committee in lieu of being appointed to the City Beautiful Commission.

Mrs. McLaughlin advised that Linda Neufeld, a Member of the Community Fiscal Analysis Committee, would like to be appointed as a Member of the City Beautiful Commission. Council concurred with said appointment.

Mr. Kenning reviewed a Liquor Permit Application submitted to the Ohio Department of Liquor Control for a D5 Permit, the Applicant being Mark Pis China Gate Corporation, DBA Mark Pis China Gate Chinese Restaurant, 6290 Far Hills Avenue.

Mr. Kenning briefly reviewed an Agreement for the City to cooperate in the Horizons Adult Daycare Program, a supervised day care program for the older generation. The Agreement was discussed by Council in detail at a previous Work Session Meeting.

Mr. Kenning reviewed a proposed Contract now required for the City to continue to purchase surplus property. Council concurred that said Contract be authorized.

Mr. Kenning reviewed a proposed amendment to reduce Permit Fees for structures under \$500.00. According to the present fee schedule, permits could cost more than the structure itself.

The proposed Ordinance regulating the operation of mopeds in the City of Centerville was discussed by Council. Upon question of Council, Mr. Farquhar advised that highway, roadway and street all have the same definition. However, Council concurred that the Ordinance be changed to define right-of-way as roadway throughout the Ordinance. Mr. Kenning pointed out the fact that two other areas of concern had been pointed out by interested persons: that mopeds not be permitted to be ridden on sidewalks, and that mopeds not be permitted on roadways upon which they could not meet the speed limit. Mr. Farquhar

recommended that Section 377.06 c. be changed to read: No person shall ride a moped upon a sidewalk, that d. be eliminated and that e. be changed to d.; and that Section 377.07 a. read as follows: No person shall park a moped in such a manner so as to obstruct pedestrian or vehicular traffic. Council concurred that these changes be made to the regular and emergency Ordinance. Also discussed was the effective date of the Ordinance. Council concurred that the effective date of the emergency Ordinance be July 1, 1983.
