The Council of the City of Centerville, County of Montgomery, State of Ohio, met in Regular Session on Monday, February 15, 1982 at 8:00 P.M. in the Council Chambers of the Centerville Municipal Building. The Meeting was opened with an Invocation given by Reverend Preston Dawes, Pastor of the Heritage United Presbyterian Church and City Chaplain and the Pledge of Allegiance to the Flag with Deputy-Mayor Nora Lake presiding. Council indicated no objection to this Application.

ORDINANCE NUMBER 4-82 ANNEXATION

The Public Hearing was held concerning Ordinance Number 4-82. Mr. Singer sponsored Ordinance Number 4-82, An Ordinance Accepting The Application Of The Lutheran Social Service Of The Miami Valley For Annexation Of Territory, and moved that it be passed. Mr. Sweetman seconded the motion. A roll call vote resulted in six ayes in favor of the motion.

ORDINANCE NUMBER 6-82 STATE ROUTE 48

The Public Hearing was held concerning Ordinance Number 6-82. Mr. Kenning reviewed this proposed Ordinance to authorize the State of Ohio to repair and resurface portions of State Route 48 within the area of Ole Spanish Village and Dale Ridge Drive. Mrs. Heintz sponsored Ordinance Number 6-82, An Ordinance Enacted By The City Of Centerville, Montgomery County, Ohio, In The Matter Of The Hereinafter Described Improvement, Under The Supervision Of The Director Of Transportation, and moved that it be passed. Mr. Singer seconded the motion. A roll call vote resulted in six ayes in favor of the motion.

Due to a potential conflict of interest, Mr. Sweetman left the Meeting at this time.

ORDINANCE NUMBER 19-80 ZONING ORDINANCE AMENDMENT REZONING-SR725

Mr. Kenning reviewed a Rezoning Application filed a few years previous by Perfect Real Investment for land located at the northeast corner of Loop Road and Alexandersville-Bellbrook Road. Following the Public Hearing, Ordinance Number 19-80 was tabled for discussion during a Council Work Session Meeting. This Rezoning was discussed during a Work Session Meeting on June 30, 1980 at which time the Applicant agreed to prepare Deed Restrictions limiting access to the Commercial area to one curb cut off Alexandersville-Bellbrook Road. Said Deed Restrictions have been prepared and reviewed by the Municipal Attorney, thus this matter is before Council for consideration. Mrs. Lake advised that Council, in reviewing this Application again, the Deed Restrictions as prepared and in consideration of the fact that there has been a change in ownership, has concurred that this Application again be discussed with the Applicant so that certain issues can be clarified. Mr. Taylor moved that Ordinance Number 19-80, An Ordinance Amending Ordinance Number 15 Dated December 11, 1961, The Zoning Ordinance, By Rezoning 63.3 Acres, More Or Less, From EC and Il Classification To Centerville B2 And R4 Classification, be tabled for discussion during a Council Work Session Meeting. Mr. Siler seconded the motion. A roll call vote resulted in four ayes in favor of the motion; Mrs. Heintz abstained. Mr. Victor Green, representing B. M. Woods the successor of Perfect Real Investment and the owner of the entire property involved, solicited prompt action by Council on this matter if the project is to proceed. Mrs. Lake placed this item on the agenda for the next Council Work Session Meeting.

Mr. Sweetman returned to the Meeting at this time.
