The Council of the City of Centerville, County of Montgomery, State of Ohio, met in Regular Session on Monday, August 16, 1982 at 8:00 P.M. in the Council Chambers of the Centerville Municipal Building. The Meeting was opened with an Invocation given by Reverend Preston Dawes, Pastor of the Heritage United Presbyterian Church and City Chaplain, and the Pledge of Allegiance to the Flag with Mayor J. V. Stone presiding. Councilmembers and City Staff present were as follows: Deputy-Mayor Charles Taylor Councilmembers Jeffrey Siler Shirley Heintz James Singer Clerk of Council Marilyn McLaughlin City Manager Darryl Kenning City Planner Alan Schwab Service Director Richard Bishop City Engineer Karl Schab Fiance Director William Bettcher Chief of Police William Randolph Municipal Attorney Robert Farquhar Administrative Assistant Jon Bormet Mayor Stone advised that Councilman Russell Sweetman and Councilman Bernard Samples were out of the City at this time, thus their absence from this Meeting. Mr. Siler moved that Councilman Sweetman and Councilman Samples be excused from this Meeting. Mrs. Heintz seconded the motion. roll call vote resulted in five ayes in favor of the motion. The Minutes of the following Meetings had been distributed prior to this Meeting: Council Meeting - August 2, 1982. Council Work Session Meeting - August 2, 1982. Mr. Singer moved that the Minutes of the foregoing Meetings be approved, as distributed. Mr. Taylor seconded the motion. A roll call vote resulted in four ayes in favor of the motion; Mr. Siler abstained. HARTFORD HOUSE APARTMENTS Mayor Stone advised that a new proposal has been received for Site Plan approval for the Hartford House Apartments, proposed to be located at 179 South Main Street in the Architectural Preservation District. This item was considered by the Planning Commission during their Meeting on July 27, 1982. This new proposal differs from that formerly considered by the Planning Commission, thus Mayor Stone recommended that it be reviewed by the Planning

Commission prior to Council's consideration. Mr. Bill Simms, Represpenting the property owner, requested that time limitations be extended to enable them to take this Site Plan revision to the Planning Commission for consideration. Mr. Singer moved that time limitations be extended concerning action by the Planning Commission and City Council so that this revision can be reviewed by the Planning Commission prior to Council's consideration. Mr. Taylor seconded the motion. A roll call vote resulted in five ayes in favor of the motion. Mayor Stone reminded adjacent property owners that they will have the opportunity to appear at other Meetings held concerning this matter.

Mr. Singer read a Proclamation issued by Mayor Stone designating the week of September 19, 1982 as Centerville Women's Civic Club Week in the City of Centerville, Ohio.

RESOLUTION NUMBER 23-82 SALT STORAGE FACILITY

Mr. Kenning reviewed a proposed Resolution to request the Fiscal Officer to certify the estimated life of a salt storage facility to be at least twenty years, that the maximum maturity of bonds for such improvement is twenty years, and that the maximum maturity of notes to be issued in anticipation of such bonds is one year if not sold at public sale. Mrs. Heintz sponsored Resolution Number 23-82, Resolution Requesting Fiscal Officer To Certify Maximum Maturity Of Bonds And Notes, and moved that it be passed. Mr. Taylor seconded the motion. A roll call vote resulted in five ayes in favor of the motion.
