

# RECORD OF PROCEEDINGS

Held October 30, 19 82

The Council of the City of Centerville, County of Montgomery, State of Ohio, met in Special Session on Saturday, October 30, 1982 at 10:00 A.M. in the Council Chambers of the Centerville Municipal Building. The Meeting was opened with an Invocation given by Reverend Lawrence Fetzer, Washington Heights Baptist Church and Pastor of the Church attended by the deceased Councilmember Leonard Stubbs. Mr. Bernie Harris, President of the Kettering Umpires Association, outlined his memorable association with Leonard as a member of the Umpires Association.


Members of City Council expressed their pleasure to serve on City Council with Mr. Stubbs and continued to emphasize his many contributions to the Centerville Community.
