Meeting

The Council of the City of Centerville, County of Montgomery, State of Ohio, met in Regular Session on Monday, March 10, 1980 at 8:00 P.M. in the Council Chambers of the Centerville Municipal Building. The Meeting was opened with an Invocation given by Councilwoman Shirley Heintz and the Pledge of Allegiance to the Flag with Mayor J. V. Stone presiding. Assistant City Manager Joseph Minner RESOLUTION NUMBER 8-80 POLICE LEVY	
Mr. Kenning reviewed a proposed Resolution to place a one-half police levy on the election ballot in June of this year. This additional revenue would provide manpower and equipment for the Police Department to keep pace with the growth and changing patterns of this Community. The levy will cost the average homeowner approximately \$7.00 annually and will generate nearly \$75,000.00 per year for the five year life of the levy. Mrs. Lake sponsored Resolution Number 8-80, A Resolution Declaring Necessity For Tax Levy In Excess Of 10-Mill Limitation In Accordance With Section 5705.19 (J) Of The Ohio Revised Code, and moved that it be passed. Mr. Stubbs seconded the motion. A roll call vote resulted in seven ayes in favor of the motion.	
THIRD NATIONAL BANK City Council reconvened following a Work Session to consider the Site	
Plan for Third National Bank, proposed to be located south of Spring Valley Road, west of State Route 48 and just east of the Centerville Municipal Building. Councilman Jeffrey Siler was absent during this item of discussion. Mr. Sweetman moved that the Site Plan for Third National Bank be approved as recommended by the Planning Commission and including amendments and addendums discussed and agreed to by Mr. Bud Stapleton, Third National Bank, during the Work Session held this date, Plan dated March 10, 1980 and signed by Mr. Stapleton. Mrs. Heintz seconded the motion. A roll call vote resulted in six ayes in favor of the motion.	
Upon question of Mr, Singer, Mr. Kenning advised that the Disaster Plan is complete. A test will be run during the first week of April. Criteria will be available for Council to review during the March 31, 1980 Work Session Meeting.	
There being no further business, the Meeting was adjourned.
