The Council of the City of Centerville, County of Montgomery, State of Ohio, met in Regular Session on Monday, May 5, 1980 at 8:00 P.M. in the Council Chambers of the Centerville Municipal Building. The Meeting was opened with an Invocation given by Councilman Leonard Stubbs and the Pledge of Allegiance to the Flag with Mayor J. V. Stone presiding. Council Meeting - April 7, 1980. Council Meeting - April 7, 1980. Mr. Siler moved that the Minutes of the foregoing Meetings be approved, as distributed. Mrs. Heintz seconded the motion. A roll call vote resulted in seven ayes in favor of the motion; however, Mr. Singer abstained from the
Minutes of the April 7, 1980 Meeting. The Oath of Office was administered to Arts Commission Member Lydia Hausman by Mr. Farquhar.
A Proclamation designating May 12 through May 18, 1980 as South Community Mental Health Agency Week in the City of Centerville, was read by Mrs. Lake and issued by Mayor Stone.
Mayor Stone read and issued a Proclamation designating May 10 to May 17, 1980 as clean-up time in the City of Centerville.
Mr. Kenning reported the following during his City Manager's Report: A Public Hearing on Federal Revenue Sharing Funds will be held Tuesday, May 6, 1980 at 6:30 P.M. in the Council Chambers. Mr. Kenning encouraged input from citizens concerning the expenditure of these funds. On behalf of the South Community Mental Health Agency, Mr. Kenning extended a special invitation to Council and to citizens at large, to an Open House on May 15, 1980 at the new Centerville-Washington Township Branch Office of South Community Mental Health Agency located at 270 Regency Ridge in the Normandy Office Complex. Mr. Kenning reviewed the Service Department Activity Report and the Building Inspection Report for the month of April, 1980.
The improvement project at the intersection of Main and Franklin Streets is progressing well. Power will soon be installed for traffic signals. Mr. Sweetman suggested that some striping be put in place until the final layer of asphalt is applied. Upon question of Mr. Stubbs, Mr. Kenning advised that receipts in the Building Inspection Department are below predictions. Mr. Stubbs suggested

that a brief presentation concerning the financial situation in certain areas of the City government be given prior to the June election, perhaps during the next Council Meeting.

Mrs. Lake, in making reference to the County's request to private waste collectors that grass clippings not be placed in the packers for dumping, questioned the City's position if such a request was made to Municipalities. Mr. Kenning will further review this matter and report his findings to Council.

ORDINANCE NUMBER 19-80 ZONING ORDINANCE AMENDMENT PERFECT REAL INVESTMENT

Mr. Kenning reviewed the Planning Commission Meeting held April 29, 1980. The Planning Commission recommended that Council set a Public Hearing on a Rezoning Request filed by Perfect Real Investment Company for property located along the north side of Alexandersville-Bellbrook Road, just east of Loop Road. Mrs. Lake moved that Ordinance Number 19-80, An Ordinance Amending Ordinance Number 15 Dated December 11, 1961, The Zoning Ordinance, By Rezoning 63.3 Acres More Or Less, From EC And II Classification To Centerville B2 And R4 Classification, be set for Public Hearing on June 16, 1980. Mr. Singer seconded the motion. A roll call vote resulted in seven ayes in favor of the motion.

SPRINGSTONE LEA PRELIMINARY PLAN

Mr. Schwab reviewed the Preliminary Plan for Springston: Lea, a development proposed to be located north of Centerville Station Road and east of Clyo Road, containing 9.4 acres of land, 11 lots and thoroughfare improvements along Centerville Station Road. The Planning Commission recommended by a 5-1 vote, approval of this Preliminary Plan subject to the street width being increased to 28 feet, to sidewalk being installed along one side of Stone House Road, and to water line sizes being approved by the Washington Township Fire Department. The City Staff had previously recommended to the Planning Commission that a stub street be required west to the adjacent property, however, following much deliberation by the Planning Commission, the Plan was recommended without the stub street. Mr. Sweetman expressed the necessity for this stub street in consideration of future development to the west.

Mr. Al Wahby, representing the Developer, reviewed this Preliminary Plan and explained the reasoning for this type layout, the development of 11 lots rather than the 16 lots permitted, to develop a Plan most sensible to the use of the land involved. He objected to constructing a stub street years in advance of being needed. He suggested that the width of pavement of the street serving the plat be 26 feet instead of 28 feet. Mr. Wahby requested more consideration relative to the improvement required to Centerville Station Road, making reference to varying widths along the roadway presently existing. Mr. Schwab reviewed for Council the varying widths along Centerville Station Road. Mr. Singer moved that the Preliminary Plan for Springstone Lea be approved, this lot layout without a stub street, subject to sidewalk being added to one side of Stone House Road and to water line sizes being approved by the Washington Township Fire Department, and that the pavement width of the interior street and the improvement width to Centerville Station Road be deferred until the Final Plan is considered. Mrs. Heintz seconded the motion. A roll call vote resulted in four ayes in favor of the motion; Mr. Sweetman, Mr. Siler and Mrs. Lake voted no.

Mr. Sweetman presented to Mayor Stone a Plaque of Appreciation to the City of Centerville from the Miami Valley Cable Television Council for use of the South Suburban facility during previous years.

Mr. Charles Whitty, 6466 Little John Circle, presented to Council a Petition signed by area residents, requesting the installation of a traffic

signal at the intersection of Thomas Paine Parkway and Bigger Road. He reviewed traffic problems at this intersection and requested favorable consideration. This matter was referred to City Staff for review.

ORDINANCE NUMBER 12-80 SUBDIVISION REGULATIONS

The Public Hearing was held concerning Ordinance Number 12-80. Mr. Kenning reviewed this proposed Ordinance which changes the width of McEwen Road to 82 feet to coincide with Montgomery County Transportation Plans. Mr. Sweetman sponsored Ordinance Number 12-80, An Ordinance Amending Exhibits "B" And "C" Of The Subdivision Regulations Of The City Of Centerville, Ohio As Adopted By Ordinance 10-1958 And Subsequently Amended And Amending Section 1121.01 (a) (10) Of The Centerville Municipal Code, and moved that it be passed. Mr. Stubbs seconded the motion. A roll call vote resulted in seven ayes in favor of the motion.

ORDINANCE NUMBER 14-80 BUILDING AND STRUCTURAL NUISANCES

The Public Hearing was held concerning Ordinance Number 14-80. Mr. Kenning reviewed this proposed Ordinance which adds sidewalk to the definition, provides a procedure when no objection is filed and provides for the recovery of costs of abatement. Mr. Singer sponsored Ordinance Number 14-80, An Ordinance Amending Chapter 1351 Of The Centerville Municipal Code Relating To Building And Structural Nuisances, and moved that it be passed. Mrs. Lake seconded the motion. A roll call vote resulted in seven ayes in favor of the motion.
