Mrs. Mildred Abbott, Mr. Fred Dyer and Mr. Fred Profit were present from RTA to review for Council a proposal for Countywide Transit System. The proposal is divided into two phases; phase one becoming operational 90 days following an election and phase two within 6 months after an election. The issue is proposed to be placed before the electorate in April of this year. Proposed fare is \$.50 with no charge for a transfer. Buses would be scheduled from 30 minutes to 1 hour apart depending upon location, service area and time of day. Used vehicles will be initially utilized for the system. Estimated travel time from Centerville to downtown Dayton is 30 to 35 minutes.

Mrs. Lake chaired this portion of the Meeting in which the Code of Ethics for Council was discussed. Council concurred that a person having a conflict or a potential conflict state the basis on which the conflict arises. If the Councilmember is in doubt, he/she shall consult the Municipal Attorney to develop in writing a statement of the potential conflict, this statement to be circulated to fellow Councilmembers.

Council reviewed an Ordinance to provide for adoption of a civil preparedness plan which would grant certain civil emergency and disaster powers to a civil preparedness director. Council concurred that this legislation be placed on the agenda for the Council Meeting February 4, 1980.

Council considered an Ordinance to amend the Municipal Code relative to weed control. Council concurred that this Ordinance be placed on the agenda for the February 4, Council Meeting.

Mayor Stone reviewed an organizational meeting he attended concerning the I-675 corridor. Another meeting is scheduled for Tuesday, January 29, 1980 to discuss how I-675 affects the various Municipalities. He asked that comments be delayed until the entire Council has an opportunity to address the subject.

Mayor Stone excused himself from the Meeting at this time because he represents a client in the area of the Cloyo Road Improvement Project; Mrs. Lake presided. Mr. Kenning suggested that an expert in the field be hired to negotiate for acquisition of property along Cloyo Road needed for right-of-way. 13 to 15 property owners are involved in this project. Council concurred with Mr. Kenning's suggestion conditioned upon the fact that most of the preparation will be done by City Staff.
