Mr. Fred Dyer, General Manager and Mr. Perry Maull, Director of Marketing, Planning and Development for RTA, were present to receive questions and provide answers concerning future RTA improvements. Discussion followed concerning the routing of buses east on Centerville Station Road, north on Clyo Road, east on Alexandersville-Bellbrook Road and north on Bigger Road instead of north on State Route 48, east on Alexandersville-Bellbrook Road and north on Bigger Road. This particular route will travel to and from the Dayton Mall. Council concurred and RTA agreed that this route be changed as above discussed. Discussed also was the erection of shelters at bus stops in the center of town. Through a cooperative effort perhaps shelters could be constructed more in keeping with the character of the neighborhood. Mr. Stubbs suggested that Service Clubs become involved in this cooperation. Mr. Maull agreed to solicit more park and ride lots.

Mr. John Spoor, Mr. Phillip Marriott and Mr. Ernest Vines, Members of the Sister City Committee, were present to discuss with Council Waterloo's proposed visit to Centerville. Mr. Spoor asked for comments from City Council relative to activities while the visitors are in Centerville.

Mr. R. Paul Perkins, Chairman for the Arts Commission, reviewed the scheduling conflict for the Area Artists Series in Centerville. It has been ascertained that the Cincinnati Symphony Orchestra can come to Centerville in February if the school gym can be committed for that time. The Arts Commission will further pursue this matter, review finances and make a final recommendation to City Council.

Mr. Ted van Ruiten, was interviewed by City Council for appointment to the Sister City Committee. Council concurred with said appointment.

Council concurred that the proposed Council Policy relative to membership on City Boards and Commissions be changed to read "appointees to all City Boards and Commissions shall be registered electors and or resident aliens of the City of Centerville".

City Council concurred that the Ordinance to create a Parks and Recreation Commission be placed on the agenda for the next Council Meeting.


Mr. Ronald Helms was interviewed for appointment on the Sister City Committee. Council concurred that legislation be prepared for said appointment.
