Held October 23, 1978

ORDINANCE NUMBER 55-78 INDUSTRIAL DEVELOPMENT REVENUE BONDS

Mrs. Lake moved that Ordinance Number 55-78, An Ordinance Authorizing The Issuance Of \$1,000,000 Industrial Development Revenue Bond Series B, Of The City Of Centerville, Ohio, For The Purpose Of Financing A Portion Of A "Project" For Centerville Associates, Ltd.; Authorizing The Issuance Of Additional Bonds; Providing For The Pledge Of Revenues For The Payment Of Said Bond; Authorizing A Bond Purchase Agreement And Loan Agreement Appropriate For The Security Of Such Revenues And To Secure Further The Payment Of Said Bond, be set for Public Hearing on November 6, 1978. Mr. Stubbs seconded the motion. A roll call vote resulted in four ayes in favor of the motion.

ORDINANCE NUMBER 56-78 INDUSTRIAL DEVELOPMENT REVENUE BONDS

Mr. Stubbs moved that Ordinance Number 56-78, An Ordinance Authorizing The Issuance Of \$2,400,000 Industrial Development Revenue Bond Series A, Of The City Of Centerville, Ohio, For The Purpose Of Financing A Portion Of A "Project" For Centerville Associates, Ltd.; Authorizing The Issuance Of Additional Bonds; Providing For The Pledge Of Revenues For The Payment Of Said Bond; Authorizing A Bond Purchase Agreement And Loan Agreement Appropriate For The Security Of Such Revenues And To Secure Further The Payment Of Said Bond, be set for Public Hearing on November 6, 1978. Mr. Singer seconded the motion. A roll call vote resulted in four ayes in favor of the motion.
