CENTERVILLE CITY COUNCIL REGULAR MEETING JULY 12, 1976

The Council of the City of Centerville, County of Montgomery, State of Ohio, met in Regular Session on Monday, July 12, 1976 at 8:00 P.M. in the Council Chambers of the Centerville Municipal Building. The Meeting was opened with an Invocation given by Reverend Howard Carter from the Emmanuel Baptist Church and the Pledge of Allegiance to the Flag with Mayor Victor Green presiding. Mrs. McLaughlin reported that a Notice of Intent to Appeal and an Appeal had been received from the Standard Oil Company concerning their request to locate a sign at North Main Street and Bradstreet Road. The Board of Architectural Review denied this request during their Meeting on June 15, 1976.

Mrs. McLaughlin also advised that a Notice of Intent to Appeal and the Appeal had been received from Mrs. Paul Lemon against a decision rendered by the Planning Commission on June 29, 1976 to deny the rezoning of the north-east corner of East Franklin Street and Cemetery Drive from R-3 to A-P zone classification.

Mr. Kenning reported the following during his City Manager's Report: The Rahn Road Improvement Project has been let to bid, bid opening is Thursday, July 15, 1976. This is a County Permissive Tax Project. The Combined General Health District has selected the Centerville

The new 25 yard refuse packer is in operation.

Mr. Kenning reviewed for Council property tax rates in all Ohio Cities.

SAMBO'S RESTAURANT

Mr. Elmer Tate, Chairman of the Planning Commission, reviewed their Meeting held June 29, 1976. He reviewed Planning Commission's unanimous approval of a revised site plan for Sambo's Restaurant. Mr. Reynolds located the proposed site on a map, being situtated on the southeast corner of Loop Road and State Route 48 in a B-2 zoned district. The plan includes one 35 foot curb cut at the northeastern corner of the property and entering upon Loop Road. The parking lot will be semi-dished to retain water run off accumulated during a heavy rain fall until the water drains into the storm system. Lighting will be located on the perimeter of the project and shine onto the building, it will be subject to approval by the City Staff. Approval of the lighting will be in accordance with the Ordinance regulating the amount of light intensity permitted. Proposed is a free standing sign in accordance with Centerville's requirements. Mrs. Lake complimented the developer on his consideration for the safety of the Citizens of Centerville in locating the curb cut off Loop Road. Mr. Stone moved that the site plan for Sambo's Restaurant as presented, be approved. Mr. McQueeney seconded the motion. A roll call vote resulted in six ayes in favor of the motion.

BUDGET 1977

The Public Hearing was held concerning the 1977 Budget; the proposed Budget to be submitted to the Budget Commission of Montgomery County. Mr. Kenning reviewed this Tax Budget, it contains those items which look feasible for appropriation in 1977. Mr. Sweetman moved that the proposed Budget for 1977 be approved for submission to the Budget Commission of Montgomery County. Mr. Stone seconded the motion. A roll call vote resulted in six ayes in favor of the motion.

ORDINANCE NUMBER 38-76 WASTE COLLECTION

The Public Hearing was held concerning Ordinance Number 38-76. Mr. Kenning reviewed the proposed Ordinance, it provides refinancing of the 1974 waste packer truck. Mr. Sweetman sponsored Ordinance Number 38-76, An Ordinance Providing For The Issuance Of \$11,883 Of Renewal Notes Of The City Of Centerville, Ohio, In Anticipation Of The Issuance Of Bonds, For The Purpose Of Paying The Cost Of Certain Solid Waste Collection Equipment, and moved that it be passed. Mr. McQueeney seconded the motion. A roll call vote resulted in six ayes in favor of the motion.
