The Council of the City of Centerville, County of Montgomery, State of Ohio met in Special Session, Monday, August 24, 1970 at 9:30 P.M. at the Municipal Building with Mayor Paul Hoy presiding. Councilmen present were as follows: J. V. Stone, John Zengel, John McIntire, Victor Green, Harold Wells, John Davis, City Manager John Griffin, Municipal Attorney Robert Farquhar, Director of Finance Ronald Budzik, and Clerk of Council Marilyn McLaughlin.

The proposed Income Tax Contract for collection by West Carrollton was discussed by Council. Mr. Davis moved that Council authorize the City Manager to follow through with negotiating the Contract, as revised, for Income Tax Collection by West Carrollton. Mr. McIntire seconded the motion. A roll call vote resulted in seven ayes in favor of the motion.

Mr. Wells advised that Mr. Tom Cloud has invited all Council Members, Trustees, City Managers, and other Elected Officials to attend a Meeting Sunday, August 30, 1970 at 7:30 P.M. at the old County Court House to discuss rates for Waste Collection throughout Montgomery County.

Waste Collection in and by the City of Centerville was discussed by Council. Mayor Hoy advised that a phone call from Mr. Doug Trask, 5439 Red Coach Road, was received by the Clerk; he feels that the Citizens of Centerville are entitled to better Waste Collection than they are now receiving from Town and Country, he did not endorse a 50-50 proposal with Town and Country. Two residents on Valley Vista Way appeared before Council concerning problems they have experienced with the present hauler. Mr. Griffin and Mr. Budzik reviewed their cost estimates for Waste Collection by the City. Further discussion revealed that, to provide a good house service, a rate between \$3.50 and \$4.00 would be necessary; this would provide some surplus in the third year for additional equipment. The cost and pros and cons of a 50-50 collection system between the City and a private hauler were reviewed. Following additional discussion concerning Municipal Waste Collection, Mr. McIntire moved that the City of Centerville direct the City Manager to go to bid for two new waste or refuse collection trucks and one used waste or refuse collection truck. Mr. Davis seconded the motion. Mr. McIntire advised that this is a hallmark and positive decision and hopes that the enthusiasm continues with the Street Superintendent as well as through the administration. A roll call vote resulted in six ayes in favor of the motion. Mr. Zengel voted no. Mr. Zengel felt the thought, concept, and idea are admirable that the City pick up waste but felt that it is premature at this time and is built on shaky ground; he feels it will bring problems and headaches. Mr. Griffin agreed with Mr. Zengel's thought but advised that he will carry out the program well.

Mr. Stone moved that Centerville develop a City flag and a City emblem and the idea be extended to the area artists. Mayor Hoy seconded the motion. A roll call vote resulted in six ayes in favor of the motion. Mr. Zengel voted no.


The Meeting was then adjourned.
