Held September 24, 19 70

The Council of the City of Centerville, County of Montgomery, State of Ohio met in Special Session, Thursday, September 24, 1970 at 8:00 P.M. at the Municipal Building with Mayor Paul Hoy presiding. Councilmen present were as follows: Victor Green, John McIntire, J.V. Stone, John Davis, City Manager John Griffin, Director of Finance Ronald Budzik, and Clerk of Council Marilyn McLaughlin.

Mr. Griffin explained his procedure outline for the acquisition of monies for the purchase of Waste Collection Equipment. Discussion followed concerning the issuance of Bond Anticipation Notes and Councilmatic Bonds. The Bond Anticipation Notes can be renewed each year for a five year period. Mr. Davis sponsored Resolution Number 19-70, Resolution Requesting Fiscal Officer To Certify As To Maximum Maturity Of Bonds, and moved that it be adopted. Mr. Green seconded the motion.

WHEREAS, this Council contemplates the issuance of bonds in the sum of \$40,000 for the purpose of acquiring garbage packer trucks and related equipment, and notes in anticipation of such bonds;

BE IT RESOLVED by the Council of the City of Centerville, Ohio, that the Director of Finance as fiscal officer be and he is hereby requested to certify to this Council the estimated life of the equipment to be acquired with the proceeds of the sale of said bonds and the maximum maturity of said bonds and notes, as provided in Sections 133.20 and 133.21 of the Uniform Bond Law of the Ohio Revised Code.

A roll call vote resulted in five ayes in favor of the motion.

Mr. Davis sponsored Ordinance Number 36-70, An Ordinance Providing For The Issuance of \$40,000 Of Notes By The City of Centerville, Ohio, In Anticipation Of The Issuance Of Bonds For The Purpose Of Acquiring Garbage Packer Trucks And Related Equipment, and moved that it be set for Public Hearing on Friday, October 2, 1970 at 7:00 P.M. Mr. Green seconded the motion. A roll call vote resulted in five ayes in favor of the motion.

A campaign for the passage of the .25% Income Tax to be on the November ballot was discussed by Council. Mr. Green suggested utilizing the citizens who worked on the campaign for the 1.25% Income Tax in June. Mayor Hoy suggested that each Councilman recruit two to four people to work on said campaign and meet at an organizational Meeting Wednesday, September 30, 1970. Mr. McIntire suggested that the Police Auxiliary review what the Police levy will mean and provide for the Police Department and conduct a campaign accordingly. He further suggested that Council take their Meetings into the neighborhoods and spend some time on the passage of the Income Tax. At these Meetings, items to be discussed should be safety, police, youth, possible juvenile officer, school crossing guards, street repair and traffic control.

Councilman John Zengel entered the Meeting at this time.

Mayor Hoy advised that two Council Meetings per week will be scheduled during the month of October and will be held in various neighborhoods, adequate publicity will be given through the newspapers. It was the general consensus of Council that the problems in each neighborhood be revealed and discussed and attempt to a solution through the profit from the Income Tax. Journal Herald Reporter Martha Edmiston suggested utilizing the Senior Citizens in the subject campaign. City Manager John Griffin suggested putting together a slide presentation for each area, revealing the area's problems. Mayor Hoy requested that the City Manager contact the Police Auxiliary to see what can be done for passage of the Police Levy, and that he prepare a list of problems existing in various areas throughout Centerville. He called a Special Council Meeting for Wednesday, September 30, 1970 at 8:00 P.M., location to be announced, at which time each Councilman should bring five people and should know what major programs Income Tax money will be used for.

Mr. Green reviewed the allocation of Local Government Funds to various Municipalities as compared to the City of Centerville. He recommended that Centerville appeal the allocation of such funds to the Board of Tax Appeals, State of Ohio, in Columbus. Mayor Hoy suggested giving this matter considerable thought and perhaps put it to the issue. Municipal Attorney Robert Farquhar was requested to prepare the necessary papers for the October 5, 1970 Council Meeting.
