Mr Davis sponsored Ordinance #3-68: An Ordinance Providing For A Table Of Organization, Personnel Classifications, Rates of Pay, and Regulations For Employees Of The Village Of Centerville, And Repealing Ordinance Numbers 2-66, 6-66, 10-66, 2-67, 5-67, 7-67 And Any Other Prior Ordinances In Conflict Herewith, And Declaring An Emergency.

Mr. Davis moved that Ordinance #3-68 be given the first reading. Mr. Zengel seconded the motion. A roll call vote resulted in five ayes in favor of the motion.


Mayor Hoy have Ordinance #3-68 its second reading by title only.

Mr. McIntire requested that a correction be made in Ordinance Number 3-68, the Ordinance needs to be amended. Solicitor Fred Young's version of Ordinance does not ascribe to the order originally considered.
