SPECIAL MEETING

The Council of the Village of Centerville, County of Montgomery,

As a result, Council discussed the problem with Mr. Ernest Kender of the Sanitary Refuse Collection for the purpose of providing uninterrupted garbage collection in the Village. Mr. Kender stated he was willing to enter into a garbage collection contract.

Mr. McClellan moved that a \$1,000 Performance Bond be posted as bond to enter into the contract and Bond to be supplied by December 1, 1966.

Mr. Davis seconded the motion. A roll call vote resulted in four ayes in favor of the motion.

Mr. McClellan sponsored Resolution #5-66,: An Emergency Resolution Granting an Exclusive Franchise for Residential Garbage and Trash Collection in the Village of Centerville.

Mr. Davis moved that Resolution #5-66 be given the first reading. Mr. McClellan seconded the motion. A roll call vote resulted in four ayes in favor of the motion.

Mayor Hoy gave Resolution #5-66 its first reading.

Mr. Davis moved to accept the first reading of Resolution #5-66. Mr. McClellan seconded the motion. A roll call vote resulted in four ayes in favor of the motion.

Mr. McClellan moved that the statutory rules and regulations for reading resolutions on three separate and distinct days be suspended and that Resolution #5-66 be given its second and third readings by title only. Mr. Davis seconded the motion. A roll call vote resulted in four ayes in favor of the motion.

Mayor Hoy gave Resolution #5-66 its second reading by title only.

PUBLIC HEARING

The Council of the Village of Centerville, County of Montgomery, State of Ohio met in Public Hearing October 31, 1966 at the Municipal Building with Mayor Paul Hoypresiding. Present were Councilmen: K. C. McClellan, John McIntire, John Davis, Richard Miller, Donald Lyons, Harold Berry, Engineer Frank Williams, and Clerk-Treasurer Ronald Budzik.

Mayor Hoy stated that this second hearing on a proposed Ordinance to provide certain new rules and regulations governing plats and subdivisions within Centerville was necessary because of various changes made in the proposed amendments since the last hearing.

The following Centerville Builders were present: Mr. Archdeacon, Mr. Zengel, Mr. Naples, and Mr. Sheley.

The builders agreed that the proposed regulations were good for the Village of Centerville if properly enforced.

The Committee who prepared the Regulations recommended that they be accepted.

Mayor Hoy and Clerk-Treasurer Ronald Budzik read the proposed Ordinance and minor corrections were noted. Mr. McIntire and Mr. Berry questioned whether the Montgomery County Numbering System should be incorporated in this Ordinance or made a separate Ordinance within itself.

Another suggestion was made to clarify the word "improvements" in the Ordinance as to when the Ordinance would take effect on subdivisions
