Regular Meeting

The Council of the Village of Centerville, County of Montgomery, State of Ohio met in regular session Monday, November 2, 1964 at 7:30 P.M. with Mayor William Gimbel presiding at the Town Hall. Councilmen present were Kenneth McClellan, Richard Knierer, Charles Taylor, Howard Griest, Clarence Stingley, John Theiss, Solicitor William Wiseman and Frank Williams, Engineer.

The minutes of the October 19, 1964 meeting were read. Mr. Theiss moved that these minutes be accepted as read. Mr. Knierer seconded the motion. A roll call vote resulted in five ayes in favor of the motion. Mr. Stingley abstained.

Mayor Gimbel gave the Mayors report as follows: .

Mayor Gimbel's Mayors Court check totaled \$722.90. Mayor Gimbel reported that the \$10.50 shortage was due to two bad checks given at Mayor's Court for \$5.00 each and a .50¢ bank charge. Mr. Taylor moved that the Mayors report be accepted as given. Mr. Griest seconded the motion. Aroll call vote resulted in six ayes in favor of the motion.

Mayor Gimbel read a letter from Mr. Robert Miller of Village South regarding streets in Village Sourt section 2 and 4.

The Police Contract for the Village of Centerville and Washington Township Trustees for 1965 was read by Mayor Gimbel. Mr. Griest moved that this contract be accepted as corrected. Mr. McClellan seconded the motion. A roll call vote resulted in six ayes in favor of the motion.

Mr. Taylor reported for the Finance Committee. Mr. Taylor moved that vouchers #497through #539 as approved by the Finance Committee be paid. Mr. Stingley seconded the motion. A roll call vote resulted in six ayes in favor of the motion.

Mr. Taylor sponsored Ordinance #10-64. AnAdditional Appropriation Ordinance.

Mr. Taylor moved that Ordinance #10-64 be given the first reading. Mr. Griest seconded the motion. A roll call vote resulted in sixayes in favor of the motion.

Mr. Taylor gave Ordinance #10-64 its first reading.

· Mr. Griest moved to accept the first reading of Ordinance #10-64. Mr. Theiss seconded the motion. A roll-call vote resulted in sixayes in favor of the motion.

Mr. Theiss moved that the statutory rules and regulations for reading Ordinances on three seperate and distinct days be suspended and that Ordinance #10-64 be given its second and third readings by title only. Mr. Taylor seconded the motion.

A roll call vote resulted in six ayes in favor of the motion.

Mr. Taylor gave Ordinance #10-64 its second reading by title only.

Mr. Theiss moved that the second reading of Ordinance #10-64 by title only be accepted. Mr. Stingley seconded the motion. A roll call vote resulted in six ayes in favor of the motion.

Mr. Taylor gave Ordinance #10-64 its third reading by title only.

Mr. Griest moved that the third reading of Ordinance #10-64 by title only be accepted and the Ordinance be passed. Mr. Theiss seconded the motion. A roll call vote resulted in six ayes in favor of the motion.

Mr. Stingley reported for the Police Committee. Mr. Stingley requested that Mr. Wiseman publish for notice of bids for a 1965 police cruiser, opening date set for December 19th, 1964 at 12:00 Noon at the Town Hall. Council advised Mr. Wiseman to have this published in the Kettering-Oakwood Times.

Mr. Stingley moved that two dispatchers, Mr. George Crynick and Mr. John Martinelli be hired by the Village of Centerville, at \$1.25 per hour, this to be retroactive to October 15, 1964. Mr. Griest seconded the motion. A roll call vote resulted in six ayes in favor of the motion.

Mr. Knierer reported for the Street Committee. Mr. Knierer reported that four permits had been issued totaling \$480.00.

Mr. Theiss reported for the Planning Board. Mr. Theiss moved that Black-Oak Preliminary Plat Plan be accepted. Mr. Griest seconded the motion.

A roll call vote resulted in six ayes in favor of the motion.

The record plan for Wellington Park, Section #1 was presented to Council. Mr. Theiss moved that the record plan for Wellington Park, Section #1 be approved subject to the Sub-Dividers Agreement and Performance Bond and inspection fee of \$409.00. Mr. Griest seconded the motion. A roll call vote resulted in six ayes in favor of the motion.

Mr. Don Polland as spokesman for a Committee opposing the Street
Lighting Issue discussed same with Council. Other members of this Committee present
were Mrs. Knudsen, Mr. Alders and Mr. Shroyer.

A representative from the Centerville Swim Club appeared before Council. After discussion by council, Mr. Stingley moved that Mr. Wiseman be authorized to determine the definition of Swim Club. Mr. Theiss seconded the motion. A roll call vote resulted in six ayes in favor of the motion.

The meeting was then adjourned.
