The Council of the Village of Centerville, County of Montgomery, State of Ohio, met in special session with Mayor William Gimbel presiding on February 20, 1963 at 7:30 P.M. Present were councilmen Richard Knierer, John Zengel, Clarence Stingley, John Theiss and Howard Griest, Engineer Frank Williams and Solicitor William Wiseman.

Mr. Jack Atkinson of Dayton Power and Light Company discussed street lighting in the Village with the council.

Mr. Griest sponsored Ordinance 1-63 which is an ordinance amending Ordinance No. 16 dated November 20, 1959, by adding thereto Section 28.241 to the Code of Ordinances of the Village of Centerville, Ohio, regulating the trimming and planting of trees and shrubs within the Village of Centerville, Montgomery County, Ohio.

Mayor Gimbel gave Ordinance 1-63 its first reading.

Mr. Griest moved that the first reading of Ordinance 1-63 be passed.
