The council instructed the solicitor to draft an ordinance regulating parking in front of the Town Hall and in the alley alongside the Town Hall.

Mayor Gimbel read resolution 3-1963 which is a resolution accepting the amounts and rates as determined by the Budget Commission and authorizing the necessary tax levies and certifying them to the county auditor. Mr. Sims moved that resolution 3-1963 be passed. Mr. Griest seconded the motion. A roll call vote resulted in six ayes in favor of the motion.
