Mr. Griest seconded the motion. A roll call vote resulted in five ayes in favor of the motion.

Mayor Gimbel gave Ordinance 9-62 its second and third reading by title only. Mr. Theiss moved that Ordinance 9-62 be passed as read. Mr. Sims seconded the motion. A roll call vote resulted in five ayes in favor of the motion.
