

Special Meeting

The Council of the Village of Centerville, County of Montgomery, State of Ohio, met in special session with Mayor Gimbel presiding October 17, 1962 at 7:30 P.M. Present were councilmen Howard Griest, Richard Knierer, Wilbur Sims, Clarence Stingley and John Zengel, Solicitor William Wiseman and Engineer Frank Williams.

The minutes of the meeting of October 1, 1962 were read. Mr. Knierer moved that the minutes be approved as corrected. Mr. Griest seconded the motion. A roll call vote resulted in five ayes in favor of the motion.

The Council discussed the possibility of "no parking" on one side of Virginia and other streets in the Village. The Solicitor was instructed to draft an ordinance for "No Parking" on Virginia.

The Council discussed speeding on streets which have not been accepted by the Village. William Wiseman stated that the Village can not enforce traffic regulations until the Village accepts the streets.

The Council discussed the public hearing for zoning of the recently annexed property North and East of the Village. The public hearing is to be November 26, 1962.

Mr. Griest gave the Street Committee report.

Mr. Griest moved that the Village buy two fire extinguishers at \$23.00 each. Mr. Knierer seconded the motion. A roll call vote resulted in five ayes in favor of the motion.

Mr. Griest read a letter from Black & Combs requesting that Lynn Rae Terrace, Section 1 be inspected and that Black & Combs be released from their performance bond.

Regular Meeting

The Council of the Village of Centerville, County of Montgomery, State of Ohio, met in regular session with Mayor Gimbel presiding November 5, 1962, at 7:30 P.M. Present were councilmen John Theiss, Howard Griest, Clarence Stingley, Richard Knierer, John Zengel and Wilbur Sims, Solicitor William Wiseman and Engineer Frank Williams.

The minutes of the meeting of August 6, 1962 were read. Mr. Theiss moved that the minutes be approved as read. Mr. Griest seconded the motion. A roll call

vote resulted in four ayes in favor of the motion. Mr. Sims and Mr. Stingley abstained as they were not present at the August 6, 1962 meeting.

The minutes of the meeting of October 17, 1962 were read. Mr. Stingley moved that the minutes be passed. Mr. Zengel seconded the motion. A roll call vote resulted in five ayes in favor of the motion. Mr. Theiss abstained as he was not present at the meeting of October 17, 1962.

Mayor Gimbel reported the following collections:

Mr. Griest moved that the mayor's report be accepted. Mr. Knierer seconded the motion. A roll call vote resulted in six ayes in favor of the motion.

Mr. Zengel, member of the Finance Committee, moved that vouchers 396 through 432, which have been approved by the Finance Committee, be paid. Mr. Sims seconded the motion. A roll call vote resulted in six ayes in favor of the motion.

The council discussed supporting the creation of a Montgomery County Park District. The idea is currently being presented to all governmental units in Montgomery County.

Mr. Sims moved that Resolution 5-62, which is a resolution to Participate in a Park District for Montgomery County, be passed. Mr. Theiss seconded the motion. A roll call vote resulted in six ayes in favor of the motion.

Mr. Griest sponsored Ordinance 11-62. Ordinance 11-62 is an ordinance regulating parking, Village of Centerville, Montgomery County, State of Ohio.

Mayor Gimbel gave Ordinance 11-62 its first reading.

Mr. Sims moved that the first reading of Ordinance 11-62 be passed. Mr. Stingley seconded the motion. A roll call vote resulted in six ayes in favor of the motion.

Mr. Theiss moved that the Statutory Rules and Regulations for reading ordinances on three separate and distinct days be dispensed with so that Ordinance 11-62 may be given its second and third reading by title only. Mr. Griest seconded the motion. A roll call vote resulted in six ayes in favor of the motion.

Mayor Gimbel gave Ordinance 11-62 its second and third reading by title only.

Mr. Sims moved that Ordinance 11-62 be passed. Mr. Griest seconded the motion. A roll call vote resulted in six ayes in favor of the motion.

Mr. Theiss reported for the Planning Board. The council discussed a meeting with the Planning Board and the Washington Township Trustees.

The council discussed the need for street lights within the Village.

Mr. Griest gave the Street Committee report. Mr. Griest moved that the Village accept Concept Plat - Section 5 and the related bond be released. Mr. Stingley seconded the motion. A roll call vote resulted in six ayes in favor of the motion.

Mr. Sims gave the Police Committee report. Mr. Sims moved that the salary of Clifford Kountz be increased from \$4,600 to \$4,800 per year effective November 1, 1962. Mr. Zengel seconded the motion. A roll call vote resulted in six ayes in favor of the motion.

Mr. Griest moved to install a phone at the garage. Mr. Stingley seconded the motion. A roll call vote resulted in six ayes in favor of the motion.
