Mr. Schubert stated his case for his land on the North West corner of Rt. 48 and Springvalley, does not want Entrance Corridor Zoning.

Mr. Jack Reynolds on West Springvalley does not want Entrance Corridor Zoning or business in this section.

Mr. Bill Kromer restated his defense of the Kelly property for B-2.

Henry Sliphorst, of Centerville Market, wants all of Main Street zoned for business.
