The Mayor read the Vilage Engineer recommendation pretaining to the bids on the sidewalks to be installed. Also a letter from a committee called "Sharing the tax". The Council discuss this letter and recommended the Mayor to discuss this matter at the next Mayor's Association meeting.

Thereupon Mr. Tamaska sponsored Ord. 20-60. "An Ord. to amend the zoning Ord. of the Village of Centerville, Ohio." Ord. 20-60 was then given its' first reading.

Mr. Tamaska then moved to pass Resolution 3-60. "A Resolution of Transferring money to certain funds," seconded by Mr. Knierer and carried. A roll resulted in 5 ayes in favor of the motion.

Awarding of the contract concerning the sidewalks were discussed. There were two bidders. (1) Triangle Contracting--\$4200.00 (2) Boyd Construction Co.--\$5095.00. The publication of bids were Nov. 14,1960 to Nov. 21,1960 and the bids were opened Dec. 3,1960 at 12:00 Noon

Mr. Knierer moved to award the contract to Triangle Contracting Co. for sidewalks according to the agreement and the bid and that the Mayor be authorized to excute the contract, seconded by Dr. Kelso and carried. A roll call resulted in 5 ayes in favor of the motion.

The publication for the purchase of a new Police Cruiser was made Nov. 14,1960 to Nov. 21,1960 and the bid were opened by the Clerk-Trens. Dec. 3,1960 at 12:00P. M. There were three bids.

(1) Stengers Ford, which did not have the \$100.00 bid bond included with the bid. (2) C. G. Mears & Son-specification did not meet the required specification as advertised. (3) C. J. Stueve Inc. This bid came in too late to be honored. Therefore the Council rejected any and all bids.

Mr. Sims then moved to readvertise for a new Police Cruiser, seconded by Mr. Rhoades and carried. A roll call resulted in 4 ayes in favor of the motion. Dr. Kelso did not vote due to an emergency call.

Mr. Knierer chairman of the St. Committee reported of the permit that was given to Oliver Upton, for the excavting in a street. He also gave the Clerk-Treas. a \$20.00 check for the permit for digging into the street, also a \$100.00 check for the Performance and Maintance Bond.

A Special Meeting was then set for Dec. 28,1960 for the following agenda. (1) closing of the business for 1960 (2) 2nd reading of Ord. 20-1960 (3) awarding of contract for the cruiser

The meeting adjourned.
