Council then directed the Engineer to furnish the break down on the operation of the sewage treatment plant to see if it was possible for the Village to operate it themselves. It was also agreed by the Council that the Village should investigate the possibilities of the County collecting the bills on a percentage bases. The Council decided that the Solicitor contact Mr. Reiber to see if a meeting could be arranged to meet with the Village of Centerville to discuss this matter of the treatment plant.

The Mayor then read a letter from Chas. Crane Realtor on behalf of Mrs. Bertha Decker, requesting the lot of 54 West Franklin Street be rezoned from R-1 to B-2. It was moved by Mr. Arnold to hold a public hearing July 14,1958 at 8:00 P.M. for the purpose of ammending zoning ordinance for 54 W. Franklin St., also instruct the Solicitor to advertise according to the zoning ordinance, seconded by Mr. Cramer and carried. A roll call resulted in 6 ayes in favor of the motion.

The meeting adjourned.

Special Meeting

The Council of the Village of 'Centerville, County of Montgomery and the State of Ohio met in a special session. June 24,1958 with Mayor Jackson presiding. Present: Richard Neal, Frank Arnold. Bernard Cramer, Gilbert Neubauer, Rol Cultice, Walter Rhoades of the Council and Engineer Leo Wall.

The purpose of this meeting was to decide who would operate the sewage treatment plant and collection system of the Huber Plat #25. Engineer Mr. Wall gave the estimate cost of this plant to operate per month. Mr. Arnold then reported to the Council of the meeting that he and Solicitor James Lynn had with the County Sanitary Dept. After general discussion. Mr. Arnold moved that the Village of Centerville turn the sewage treatment plant and collective system

of the Huber Plat #25 over to the County Sanitary Dept. to operate, and they shall be informed immediately of the Council action, seconded by Mr. Neal and passed. A roll call resulted in 6 ayes in favor of the motion.

The Mayor then presented Plat #5 of Centervilla the subdividors agreement between Huffman & Shawen and the Village of Centerville.

The resurfacing of State Route 48 from the South Corp.

limits of Centervilleto a point approximately 1.4 miles North of the South Corp. line of Centerville was discussed.

Thereupon, Mr. Neubauer introduced Ord. 12-58. An ordinance in the matter described "improvement," of State Route 48 under the supervision of the Director of Highways." Mr. Neal made the following motion, "I move the statutory rule for reading Resolutions and Ordinances on three separate and distinct days be despensed with so Ord. 12-58 may be given its second and third readings," seconded by Mr. Rhoades and carried. A roll call resulted in 6 ayes in favor of the motion. Then Ord. 12-58 was given its second and third readings. The question being, shall Ord. 12-58 be passed? It was moved by Mr. Arnold, seconded by Mr. Cultice and carried that Ord. 12-58 be passed. A roll call was ordered which resulted as follows; Mr. Arnold, aye; Mr. Cultice, aye; Mr. Neubauer, aye; Mr. Rhoades, aye; Mr. Cramer, aye; Mr. Neal, aye; This Ordinance was passed as an emergency measurer.

The Council then discussed the drainage system in Plats 1-2-3-4- of Centervilla. It was moved by Mr. Arnold, seconded by Mr. Neal and carried that the Engineer and St. Committee meet with Huffman & Shawen and insist that the drainage system be restored to the original specifications. A roll call resulted in 6 ayes in favor of the motion.

The Street Committee and the Engineer are to meet with Mr. Gorman to discuss the releasing of the bond that the Village now holds on a portion of Hampton and Davis Drive.

The meeting adjourned.
