**RESOLUTION AUTHORIZING THE ADDITIONAL APPROPRIATIONS OF UP TO \$190,000 FOR THE OVERBUILD CONSTRUCTION AND MAINTAINANCE OF A BROADBAND FIBER NETWORK AND AUTHORIZING THE CITY MANAGER TO TAKE ALL STEPS NECESSARY TO IMPLEMENT THE OVERBUILD PROJECT.**

**WHEREAS**, the City of Centerville had entered into an Memorandum of Understanding (MOU) with several Miami Valley Communications Council (MVCC) cities for the establishment of a broadband fiber network project (Project); and

**WHEREAS**, the Project is proceeding as previously approved; and

**WHEREAS**, it has been identified that there is a need to overbuild the State Route 48 from Spring Valley Road to Alex Bell Road portion of the Project at a projected cost of \$187,716.19 (Overbuild Project); and

**WHEREAS**, there is a desire to construct this Overbuild Project as part of the additional broadband fiber network in and around the geographical region, with the goal of realizing benefits that include faster internet speed, cheaper rates, shared service, and increased connectivity; and


**WHEREAS**, it is in the best interests of the City to continue to proceed pursuant the MOU with these other entities, but to also have the ability to provide for the Overbuild Project as needed.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CENTERVILLE, MONTGOMERY COUNTY, OHIO, AS FOLLOWS:**

Section 1. The City of Centerville hereby authorizes the additional appropriations of up to \$190,000 for the Overbuild Project and authorizes the City Manager to take any steps necessary to complete the Overbuild Project in addition to the project pursuant to the MOU.

Section 2. This Resolution shall be in full force and effect at the earliest date allowed by law.
